

State Health Society - Tamil Nadu - National Health Mission - Placing of 12 posts of Audiometric Assistant at one per District for the ongoing scheme of National Programme for Prevention and Control of Deafness (NPPCD) on Outsourcing-Permitted - Orders - Issued.

## ORDER:

In Government order first read above, Government have formed a sub-committee at State and District level for National Programme for prevention and control of Deafness. In Government order 2<sup>nd</sup> read above, Government have permitted the Mission Director, State Health Society, Tamil Nadu to appoint one Audiometric Assistant and one Instructor for the Young hearing Impaired in each of the 19 Districts namely Vellore, Villupuram, Thanjavur Coimbatore, Cuddalore, Dharmapuri, Dindigul, Erode, Madurai, Nagapattinam, Namakkal, Pudukottai, Ramanathapuram, Salem, The Nilgiris, Tiruvarur, Trichy, Tirunelveli and Tiruvannamalai on consolidated pay of Rs.7500/- per month. Subsequently, in Government order third read above, Government amended the Government order second read above as "the recruitment of above post may be made from Employment Exchange only with rule of reservation to be followed".

- 2. In the letter 4<sup>th</sup> read above the Mission Director, State Health Society has also stated that in the Record of Proceedings 2017-18, the Government of India had approved Rs.5.06 lakh towards the salary cost for 15 posts of Audiometric Assistant for 3 months and in 2<sup>nd</sup> Supplementary Record of Proceedings 2017-18 the Government of India has approved Rs.2.40 lakh for additional 16 posts of Audiometric Assistant at the rate of one per district with salary of Rs.15000/- per month for 1 month.
- 3. The Mission Director, State Health Society has also stated that a proposal to appoint one Audiometric Assistant in each of the 12 Districts namely Kancheepuram, Kanyakumari, Karur, Krishnagiri, Perambalur, Sivagangai, Thoothukudi, Theni, Virudhunagar, Thiruvallur, Thiruppur and Ariyalur has been placed before the 34th Executive Committee meeting vide Agenda No. 8 and the same was approved.

- 4. The Mission Director, State Health Society has also stated that as on 31<sup>st</sup> December 2017, the above sanctioned 19 posts of Audiometric Assistant has been kept vacant due to difficulty in getting qualified hands with the low consolidated pay of Rs.7,500/- per month. Hence he has proposed for revision of pay from Rs.7500/- per month to Rs.15,000/- per month as approved in Record of Proceedings 2017-18 and 2<sup>nd</sup> Supplementary Record of Proceedings 2017-18 and change the mode of appointment from employment exchange to outsourcing. The above proposal was also placed before the 34<sup>th</sup> Executive Committee meeting vide agenda no. 8 and the same was approved.
- 5. The Mission Director, State Health Society has therefore requested Government orders in this regard.
- 6. After careful examination, the Government have decided to accept the proposal of Mission Director, State Health Society and accordingly issue the following orders:
  - i. The Mission Director, State Health Society is permitted to appoint 12 posts of Audiometric Assistant in 12 Districts namely Kancheepuram, Kanyakumari, Karur, Krishnagiri, Perambalur, Sivagangai, Thoothukudi, Theni, Virudhunagar, Thiruvallur, Thiruppur and Ariyalur through outsourcing through District Health Society with a consolidated pay of Rs.15,000/- per month with 5% annual increment.
  - ii. The Mission Director, State Health Society is permitted to revised the salary of 19 posts of Audiometric Assistant sanctioned in the Government Order second read above from Rs.7,500/- per month to Rs.15,000/- per month.
  - iii. In partial modification of orders issued in para 7 (i) in the Government Order second read above, the mode of recruitment of the post of 19 Audiometric Assistant be changed from "through Employment exchange with rule of reservation" as "Outsourcing through District Health Society".
  - iv. The Mission Director, State Health Society is permitted to release the salary cost to the districts under National Programme for Prevention and Control of Deafness funds after filling up of the above posts through outsourcing.
