### ORDER:

In the Budget Speech 2010-2011, an announcement was made that Hostel and Auditorium will be constructed for the students of Madras Medical College, Chennai at a cost of Rs.20.00 Crores.

- 2. The Director of Medical Education has stated that the Government have issued administrative and financial sanction of Rs.20.00 Crores in Government Order first read above, towards construction of Hostel buildings for 450 girl students of Madras Medical College at Old Jail Campus, Chennai.
- 3. The Director of Medical Education has forwarded the revised administrative sanction proposal for a sum of Rs.20,49,21,322/- received from the Engineer-in-Chief (Buildings) and Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai duly countersigned towards construction of Hostel buildings for 450 girl students of Madras Medical College at Old Jail Campus, Chennai and she has requested to accord Revised Administrative Sanction for a sum of Rs.20,49,21,322/- against the original sanction of Rs.20,00,00,000/- stating that the difference is due to tender excess.

4. The Engineer in Chief and Chief Engineer (Buildings) Public Works Department, Chennai has furnished the following details regarding the tender excess and other charges resulting in the revised administrative sanction:-

- 5. The Tender Award Committee in its 206th meeting on 13.08.2014 has approved the revised administrative sanction proposal for a sum of Rs.20,49,21,322/- towards the construction of Hostel buildings for 450 girl students of Madras Medical College at Old Jail Campus, Chennai, with an instruction that, there should not be any further revised administrative sanction subject to accuracy, correctness and genuineness of all informative data furnished by the Chief Engineer (Buildings), Public Works Department, Chennai.
- 6. The Government examined the proposal of the Director of Medical Education in detail and accord Revised Administrative and Financial Sanction for a sum of Rs. 20,49,21,322/- (Rupees Twenty Crore Forty Nine Lakhs Twenty One Thousand Three Hundred and Twenty Two only) towards construction of Hostel buildings for 450 girl students of Madras Medical College at Old Jail Campus, Chennai as against the original administrative sanction of Rs.20,00,00,000/- with an instruction that, there should not be any further Revised Administrative Sanction, subject to accuracy, correctness

and genuineness of all informative data furnished by the Chief Engineer (Buildings), Public Works Department, Chennai.

7. The expenditure sanctioned in para 6 above shall be debited following head of account.

"4210-Capital Outlay on Medical and Public Health – 01.Urban Health Services 110 Hospital and Dispensaries (including Pharmacy) – Schemes in Twelfth Five Year Plan –II. State Plan – JA Building.16 Major Works (DPC 4210.01.110.JA.1602)"

- 8. The expenditure sanctioned in para 6 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will initially met by an advance from the Contingency Fund. Orders regarding the sanction of advance from the Contingency Fund will be issued by the Finance (BG.I) Department separately. The Chief Engineer (Buildings) Public works Department Chennai-5 is directed to send an application in the prescribed format along with copy of this order to Finance (BG.I) Department for sanction of advance for the required quantum. The Chief Engineer (Buildings) Public works Department Chennai-5 is also directed to send necessary draft note for inclusion of Expenditure in the Supplementary Estimate for 2014-15 to obtain the approval of the Legislature at the appropriate stage
- 9. This order issues with the concurrence of the Finance Department vide its U.O. No.4834/Health-II/2015, dated:12.02.2015 and A.S.L. No. 2453 (Two Thousand Four Hundred and Fifty Three)
