### **ORDER:-**

The Director of Public Health and Preventive Medicine, Chennai has submitted proposal for premature condemnation of the following vehicle:-

2. The condemnation board, for the State Government vehicles under the control of the Director of Public Health and Preventive Medicine which has been constituted in the Government Order second read above, has stated that the vehicle No. TN25 G 0228, Tempo Traveller has covered 1,15,161 kms and 10 years against the norms of 2,50,000 kms and 10 years prescribed for normal condemnation of diesel driven vehicles and the above said vehicle requires extensive repairs. Based upon the report of the expert committee headed by the Workshop Superintendent Regional Workshop(H), Vellore of the Tamil Nadu State Health Transport Department, the condemnation board

has recommended for the premature condemnation of vehicle TN 25 G 0228, as it would not be economical to incur a huge expenditure to make the said aged vehicle road worthy.

3. The Government have carefully examined the proposal of the Director of Public Health and Preventive Medicine, along with the report of the Expert Committee and the recommendations of the condemnation board constituted for the State Government Vehicles under the Control of the Director of Public Health and Preventive Medicine and have decided to accept it. Accordingly, Government hereby issue orders for the premature condemnation of the vehicle as detailed below:-

4. The Government also direct that the procedure laid down in the Government Order first read above, should be followed while disposing of the above condemned vehicle. It is also directed to remit the sale proceeds into Government Account received by way of auction of the above said vehicle.
