#### ORDER:

The Chairman, Ave Maria Educational and Charitable Trust, Panaravilai, Kannankarai, Veeyanoor Post, Kanyakumari District has requested the Government to grant permission to start four years Bachelor of Physiotherapy (BPT) course in the name and style as "Maria College of Physiotherapy", Attoor, Thiruvattar Post, Kanyakumari District with an annual intake of 60 seats from the academic year 2020-2021.

- 2. In Government letter third read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed Physiotherapy College has fulfilled the conditions prescribed by the Government in the Government Orders first to second read above.
- 3. In his letter fourth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government and recommended to grant permission to the Chairman. Ave Maria Educational and Charitable Trust, Panaravilai, Kannankarai, Veeyanoor Post, Kanyakumari District to start four years Bachelor of Physiotherapy (BPT) course in the name and style as "Maria

College of Physiotherapy", Attoor, Thiruvattar Post, Kanyakumari District with an annual intake of 50 seats from the academic year 2020-2021.

- 4. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education. The Government hereby grant permission to the Chairman, Ave Maria Educational and Charitable Trust, Panaravilai, Kannankarai, Veeyanoor Post, Kanyakumari District to start four years Bachelor of Physiotherapy (BPT) course with an annual intake of 50 (fifty) students in the name and style as "Maria College of Physiotherapy", in S.F. Nos. 149/2A, 162/1B3A and 149/1A in the existing building of Maria College of Engineering and Technology at Attoor Village, Thiruvattar Taluk, Kanyakumari District 629 177 from the academic year 2020-2021, subject to fulfill the following specific conditions along with other general conditions laid down in G.O (Ms) No.81, Health and Family Welfare (PME.2) Department, dated: 14.03.2018, as applicable to this proposal before admitting the students:-
  - The Trust should obtain the building completion certificate from the competent authority, i.e. PWD Engineer.
  - ii. The Trust hould obtain Clearance Certificate from the State Pollution Control Board.
  - iii. The Trust should obtain affiliation from the Tamii Nadu Dr. M.G.R. Medical University, Chennai for the proposed Physiotherapy Institution.
- 5. The Director of Medical Education is directed to take necessary further action accordingly.
