ORDER:

In the letter second read above, the Director of Public Health and Preventive Medicine has stated that, the Managing Director, Aavin has mentioned that the supply of Ghee in market are packed in 500 ml pack and not in 500 grams. The cost of 500 grams of ghee is more than the existing MRP of 500 ml ghee pack. The existing packing material of ghee 500 ml supplied by Aavin in Market cannot be used for packing of 500 grams ghee and an exclusive type of PET Jar has to be manufactured which will take long time. The Managing Director, Aavin has requested to obtain necessary amendment to the Government Order to supply 500 ml Aavin Ghee instead of 500 grams of ghee in the existing PET Jar and existing MRP(Maximum Retail Price). Hence, the Director of Public Health and Preventive Medicine has requested to amend item No.V para 7 of G.O.(Ms).No.118, Health and Family Welfare Department, dated 02.04.2018 by substituting 500 ml Aavin Ghee instead of 500 gram Aavin Ghee in the existing PET jar and MRP.

2) The Government after careful examination have decided to accept the proposal of Director of Public Health and Preventive Medicine and to issue the following amendment to the G.O(Ms)No.118 Health and Family Welfare (P-2) Department, dated 02.04.2018.

AMENDMENT

For the existing para 7 (v) in G.O(Ms)No.118 Health and Family Welfare (P-2) Department, dated 02.04.2018, instead of Aavin ghee 500 gms the following shall be substituted,

"7(v) Aavin Ghee – 500 ml"
while the other things remain the same
