ORDER:

In the Government order first read above, the Government have accorded Administrative and Financial Sanction of Rs.123.30 crore to carry out the work for Construction of Government Medical College and Hospital at Block 'B' in Omandurar Government Estate, Chennai.

- 2. In the Government order second read above, the Government have accorded Revised Administrative Sanction of Rs.273,74,58,388/- to carry out the said works in the New Government Medical College (Block-B) and Hospital at Omandurar Government Estate, Chennai.
- 3. In the letter third read above, the Director of Medical Education has stated that additional funds are required to carry out the additional works in Operation Theatres, additional amenities to ICU, IMCU, fire tender road, protection wall and other works in Tower 1, 2 & 3 at Government Medical College Hospital in Block 'B' at Omandurar Government Estate, Chennai. Hence, he has forwarded the lough cost estimate prepared by the Chief Engineer (Buildings) duly countersigned by him for carrying out the additional works in Tower 1 to 3 of Government Medical College and Hospital in Block "B" at Omandurar Government Estate, Chennai at a cost of Rs.71.50 crore for the year 2017-2018 and at a cost of Rs.78.65 crore for the year 2018-2019 by adding 10% of escalation cost.
- 4. The Director of Medical Education has, therefore, requested the Government to accord necessary administrative and financial sanction for carrying out the additional works in Operation Theatres, additional amenities to ICU, IMCU, fire tender road, protection wall and other works in Tower 1 to 3 of Government Medical College and Hospital in Block B at Omandurar Government Estate, Chennai

at a cost of Rs.71.50 crore for the year 2017-2018 and at a cost of Rs.78.65 crore for the year 2018-2019 by adding 10% of escalation cost .

- 5. The Government after careful examination of the proposal of the Director of Medical Education accord administrative and financial sanction for a sum of Rs.71.50 crore (Rupees Seventy one crore and fifty lakh only) for carrying out the additional works in Operation Theatres, additional amenities to ICU IMCU, etc, and other works in tower 1 to 3 of Government Medical College and Hospital in Block 'B' at Omandurar Government Estate Chennai.
- 6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:-

"4210.Capital Outlay on Medical and Public Health – 01.Urban Health Services – 110. Hospitals and Dispensaries (Including Pharmacy) - State's Expenditure – JA. Buildings – 16. Major Works (D.P.C 4210-01-110-JA-1602)".

- 7. The expenditure of Rs.71.50 crore sanctioned in para-5 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director of Medical Education is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Director of Medical Education is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2017-2018 to Finance (BG.I) Department at the appropriate time without fail.
- 8. This order issues with the concurrence of the Finance Department vide its U.O.No.4859//Health-II/2018, dated: 05.02.2018 and ASL No.2659 (Two thousand six hundred and fifty nine).
