ORDER:

In the Government Order first read above, the Government have accorded administrative and financial sanction for a sum of Rs.130,88,00,000/- for the construction of new Government Medical College and Hospital in the Master Plan Complex at Thiruvannamalai.

2. The Engineer-in-Chief and Chief Engineer (Buildings), Public Works Department, Chennai has sent the revised estimate for the construction of new Government Medical College and Hospital Buildings in the Master Plan Complex at Thiruvannamalai for a sum of Rs.138,93,15,536/-. He has stated that the additional amount is due to tender excess and that as no provision has been made in the original sanction, revised sanction is required to meet out the additional amount. The details towards tender excess and other charges are as follows:-

3. The Director of Medical Education has requested the Government to accord revised administrative sanction for a sum of Rs.138,93,15,536/- against the original sanction of Rs.130,88,00,000/- for the construction of new Government Medical College and Hospital Buildings in the Master Plan Complex at Thiruvannamalai, stating that the additional amount is due to tender excess.

4. The proposal has been cleared by Technical Advisory Committee constituted in G.O.(Ms) No.146, Public Works Department, dated 12.08.2011 to scrutinize the revised administrative sanction proposal in respect of all technical and financial aspects involved in the work and the Tender Award Committee in its 196th meeting on 05.02.2014 has approved the revised administrative sanction proposal for a sum of Rs.138,93,15,536/- for the construction of new Government Medical College and Hospital Buildings in the Master Plan Complex at Thiruvannamalai against the original administrative and financial sanction of Rs.130,88,00,000/- with an instruction that there should not be any further revised administrative sanction and subject to accuracy, correctness and genuineness of all informative data furnished by the Engineer-in-Chief (Buildings), Public Works Department, Chennai .

5. The Government have examined the proposal of the Director of Medical Education and decided to accept the same. Accordingly, revised administrative sanction is accorded for a sum of Rs.138,93,15,536/- (Rupees One Hundred and Thirty Eight Crores Ninety Three Lakhs Fifteen Thousand Five Hundred and Thirty Six only) for the construction of new Government Medical College and Hospital Buildings in the Master Plan Complex at Thiruvannamalai as against the original administrative and financial sanction of Rs.130,88,00,000/-.

6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:-

"4210-Capital Outlay on Medical and Public Health-01 Urban Health Services - 110 – Hospitals and Dispensaries (Including Pharmacy) – Schemes in the Twelfth Five Year Plan – II State Plan – JA Buildings -16 Major Works"

7. Necessary funds will be provided in Revised Estimate / Final Modified Appropriation 2014-2015. Pending provision of additional funds in Revised Estimate / Final Modified Appropriation 2014-2015, the Chief Engineer (Buildings) is authorised to draw and utilize the amount sanctioned in para 5 above. However this expenditure will be brought to the notice of the legislature by specific inclusion in the Supplementary Estimates 2014-2015. The Chief Engineer (Buildings), Chennai is directed to include this item of expenditure while sending the proposal for Revised Estimate / Final Modified Appropriation 2014-2015 and send necessary drafts explanatory notes for inclusion of the expenditure of the Supplementary Estimate to the Government in Finance (Health-II/BG-I/PW-I) Department without fail.

8. This order issues with the concurrence of Finance Department vide its U.O.No.68712/Health-II/2014, dated 24.12.2014 and ASL No.1886 (One Thousand Eight Hundred and Eighty Six).
