ORDER:

In the Government order first read above, orders have been issued appointing 29 candidates who were selected by the Tamil Nadu Public Service Commission for the year 2013–2014, as Health Officer temporarily in the Tamil Nadu Public Health Service by direct recruitment.

2. In the Government Orders second, third and fifth read above, orders have been issued appointing substitute candidates from the Reserve list against the vacancy caused due to the cancellation of provisional selection of candidates. Out of 40 candidates (29+11) selected only 30 candidates (22+8) have joined duty as Health Officer in Tamil Nadu Public Health Service for the year 2013-2014.

- 3. In the Government Orders fourth and sixth read above, orders have been issued accepting the resignation of Dr.M.Vinoth (MBC/DC) and Dr.M.Santhoshkumar (BC/OBCM).
- 4. In the letter seventh read above, the Director of Public Health and Preventive Medicine has stated that one candidate Dr.B.Dineshkumar has filed a W.P.(MD) No.12282 of 2020 and W.M.P.(MD) No.10533 of 2020 and in the order ninth read above the Hon'ble Madurai Bench of Madras High Court has disposed the Writ Petition with the following orders:-

- (ii) A direction, therefore is hereby given to the second respondent to act upon immediately on the letter sent by the first respondent dated 29.09.2020 addressed to the second respondent and accordingly, operate the reserved list meant for MBC/DC (General) for the post of Health Officer in Tamil Nadu Public Health Services 2013-14, for which selection was conducted by the second respondent / Tamil Nadu Public Service Commission, following the issuance of notification in No.22 of 2014, dated 10.12.2014 within a period of four weeks from the date of receipt of a copy of this order;
- (iii) On receipt of the communication sponsoring the candidature of the petitioner who is undoubtedly in S.No.1 in the wait list meant for MBC/DC(General), to fill up the post of Health Officer, which vacancy caused due to the resignation of one Dr.M.Vinoth, whose resignation has been accepted by the Government through G.O.(D)No.329, Health and Family Welfare Department, issued on 13.03.2020, the Appointing Authority/ first respondent shall issue order of appointment as Health Officer to the petitioner within a period of two weeks thereafter;
- 5. The Director of Public Health and Preventive Medicine has requested the Government to move the Tamil Nadu Public Service Commission to release the reserve list candidates of the year 2013-2014 for the post of Health Officer in Tamil Nadu Public Health Service for two vacancies due to resignation of Dr.M.Vinoth (MBC/DC) and Dr.M.Santhoshkumar (BC/OBCM) in SI.No.10 and 17 respectively.
- 6. In the letter eighth read above, the Commission has been requested to allot 2 new candidates from the reserve list for appointment to the post of Health Officer in Tamil Nadu Public Health Service.
- 7. In the letter tenth read above, the Tamil Nadu Public Service Commission has allotted substitute one candidate viz., Or.B.Dinesh Kumar (Sl.No.30A12) who has been selected supplementally against the vacancy caused due to the resignation of Dr.M Vinoth. The candidate may now be placed below the last candidate selected supplementally to the said post viz. Tmt./Selvi T.Dhivyaa, Sl.No.30A11 of the supplemental selection list communicated in the Commission's letter dated 2.2.2018. The selected candidate possesses adequate knowledge in Tamil. For another vacancy caused due to the resignation of Dr.M.Santhosh Kumar, no candidate is available in the reserve list in the BC (OBCM) category

- 8. The Government after careful examination decided to issue appointment order to the candidate altotted by the Tamil Nadu Public Service Commission. Accordingly, the Government do and hereby approve the name of one candidate viz., Dr.B.Dinesh Kumar (SI,No.30A12) who has been selected by the Tamil Nadu Public Service Commission supplementally from the reserve list for the post of Health Officer in Tamil Nadu Public Health Service for the year 2013-2014 and appoint him temporarily under Section 7 (i) of Tamil Nadu Government Servants (Conditions of Service) Act, 2016 as Health Officer in Tamil Nadu Public Health Service with effect from the date of taking charge subject to the remarks received in the character and antecedent report with the condition that he should acquire the required Public Health qualification for declaration of probation which shall be 4 years on duty, within a continuous period of 5 years from the date of his appointment. If he failed, his probation will be terminated and he will be discharged from service.
- 9. The selection of the above candidate is provisional, subject to the outcome of Writ petitions relating to the recruitment, if any, pending on the files of the High Court, Madras / Madurai Bench of Madras High Court.
- 10. The Director of Public Health and Preventive Medicine is directed to adhere the following conditions white issuing postings to the above mentioned appointee:-
 - (i) He may be given 30 days time to join duty from the date of receipt of posting orders to join duty.
 - (ii) While issuing posting order to the candidate, a paragraph should be included in the proceedings that no kind of representation from the candidate would be entertained and that failure to join duty within 30 days from the date of receipt of posting order by the candidate at the specified place would result in removal of his name from the approved list. It would also be made clear in the posting order, that no Health Officer would be on leave on any account and that failure to join duty within the time allowed (One month) would be construed as unwillingness on his part to accept the appointment and action will be taken to remove his name from the approved list.
 - (iii)The posting order should be sent to the candidates by 'Registered Post with Acknowledgement Due' [RPAD] and the acknowledgement should be watched. If the candidate fails to join duty within the stipulated time, necessary proposal may be sent to Government to remove his name from the approved list in consultation with Tamii Nadu Public Service Commission.
 - (iv)The certificate of physical fitness should be obtained from the selected candidate appointed temporarily as Health Officer before joining duty after due verification.
 - (v) As the selected candidate do not possess the qualification prescribed in para 4 (B) (a) of the Commission's notification dated 10.12.2014, the selected candidate must fulfill the conditions stipulated in para 4(B) of the said notification and that a specific paragraph in this regard may be incorporated in the appointment order to be issued to the candidate.

- (vi) It shall be ascertained from the candidate selected and joined duty as to whether he has registered his name in the concerned Employment Exchange and if so, he may be asked to surrender his Employment Exchange Identity Card either to the Director of Public Health and Preventive Medicine or to the Employment Exchange where the candidate has registered his name or to the Director of Employment and Training, Chennai, so that the registration of the concerned candidate shall be removed from the live register of the Employment Exchange.
- (vii)The Director of Public Health and Preventive Medicine has to report to Government about the name of candidate who have taken up the temporary appointment and whose name have to be removed from the approved list on account of his failure to join duty within the stipulated time (one month), if necessary.
