The Director of Public Health and Preventive Medicine, in his letter 2nd read above has stated that Dean, Vinayaka Mission's Kirupananda Variyar Medical College and Hospitals, Salem has sought permission to have tie up arrangement with the Primary Health Centers at Nainampatti and Poolavari in Salem Health Unit District to undergo community medicine training by their MBBS students and has requested necessary orders in this regard.

The Government, after careful examination, on the recommendation of the Director of Public Health and Preventive Medicine, have decided to accept the same and grant permission to the Dean, Vinayaka Mission's Kirupananda Variyar Medical College and Hospitals, Salem to have tie-up arrangements with the Primary Health Centers at Nainampatti and Poolavari in Salem Health Unit District for a period of three years from the academic year 2015–2016 to 2017-2018 for availing filed practice of their Medical students, subject to the following conditions:-

- i) The field visit should not be detrimental to the normal functioning of those Primary Health Centres;
- ii) The students should be deputed in small batches;
- iii) The Institution should pay the fees prescribed as per G.O (D) No.1258, Health and Family Welfare Department, Dated: 20.11.2014.

3. The Director of Public Health and Preventive Medicine is directed to take necessary action accordingly.
