Further, during the month of July, Government of India have released of Rs.12,27,00,000/- Grants-in-Aid for implementation of activities approved in Ayushman Bharat – Health and Wellness Centres covered under National Urban Health Mission Flexible Pool during the Financial Year 2020-21 and credited into State Government Account for drawal of the said amount through treasury as detailed below:-

The corresponding 40% of the State Share against the 60% of the Government of India release of Rs.12,27,00,000/- (Rupees Twelve Crore and Twenty Seven Lakh Only) works out of Rs.8,18,00,000/- (Rupees Eight Crore and Eighteen Lakh Only).

- 2. Further, the Mission Director, National Health Mission has stated that, the grants-in-aid for a sum of Rs.20.45 crore was sanctioned for implementation of activities approved in Ayushman Bharat Health and Wellness Centres covered under National Urban Health Mission Flexible Pool and the activities to be undertaken as per Record of Proceeding for the Financial year 2020-21 in Metro and Non-Metro cities from the above requested amount is as follows:-
 - A sum of Rs.7.77 Crores has to be released for the procurement of Drugs to Auyushman Bharat – Health & Wellness Centre of 140 Urban Primary Health Centres in Greater Chennal Corporation (FMR – U.6.2.1.1).
 - A sum of Rs.12.68 Crores for the procurement of Drugs to Auyushman Bharat – Health & Weilness Centre of 140 Urban Primary Health Centres in Non-Metro (FMR – U.6.2.1.1).
- 3. The Mission Director, National Health Mission has requested the Government to issue early orders in this regard.
- 4. The Government after careful consideration have decided to accept the above proposal of the Mission Director, National Health Mission and accordingly sanction a sum of Rs.20,45,00,000/- (Rupees Twenty Crore and Forty Five Lakh Only) towards the Central and State Share for implementation of activities approved in Ayushman Bharat Health and Wellness Centres covered under National Urban Health Mission Flexible Pool during the Financial Year 2020-21.
