



## ABSTRACT

### ORDER:

In the Government Order first read above, among others, the Government have permitted the Mission Director, National Health Mission to utilize the State share of liquidation of arrears for infrastructure maintenance to the tune of Rs.4,65,25,000/- (Rupees Four crore sixty five lakh twenty five thousand only) to complete the civil works in 23 Primary Health Centres / Upgraded Primary Health Centres out of pending 62 civil works under National Health Mission. The remaining 39 works were referred to Public Works Department, Tender award committee, for which approvals were issued for 13 pending works along with 9 new works. In the Government orders second read above, sanction was accorded for a sum of Rs.281.72 lakh for a execution of Civil Works in 16 Primary Health Centres / Upgraded Primary Health Centres through the Public Works Department. In the Government order third read above, the Mission Director, National Health Mission is permitted to utilize the available funds for provision of additional funds for a sum of Rs.9,79,46,897/- for the four civil works.

2. The Mission Director, National Health Mission in his letter fourth read above, has stated that Public Works Department has communicated Tender Award Committee approvals issued for the provision of additional funds for the following works:
