### ORDER:

- 2. The Registrar, Dr. M.G.R. Educational and Research Institute, Maduravoyal, Chennai run by Tmt. Kannammal Educational Trust, Chennai has requested the Government to grant permission to enhance the seats in B.Sc (Nursing) course from 50 to 100 at College of Nursing, Dr. M.G.R. Educational and Research Institute, (Deemed to be University) Maduravoyal, Chennai.
- 3. In Government letter eighth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first to second and fourth to seventh read above and as per the norms of the Indian Nursing Council, New Delhi.

In his letter ninth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi and recommend to grant permission to the Registrar, Dr. M.G.R. Educational and Research Institute, Maduravoyal, Chennai run by Tmt. Kannammal Educational Trust, Chennai to enhance the seats in B.Sc (Nursing) course from 50 to 100 at College of Nursing, Dr. M.G.R. Educational and Research Institute, (Deemed to be University) Maduravoyal, Chennai.

Educational and Research Institute (Deemed to be University) in the existing building of A.C.S. Medical College and Hospital in S.F. Nos. in 35/1, 35/2, 35/3, 63/2, 64/1A & 64/1B2, Maduravoyal, Chennai 600 095, subject to fulfill the specific conditions along with other general conditions laid down in G.O (Ms) No.219, Health and Family Welfare (PME.2) Department, dated: 06.06.2018 as applicable to this proposal and the Trust should obtain recognition from the Tamil Nadu Nurses and Midwives Council, Chennai and if needed, suitability from Indian Nursing Council, New Delhi, respectively before admitting the students.
