Medical Education - Rajah Muthiah Medical College attached to Annamalai University and related institutions - Handed over to Health and Family Welfare Department for treating it as Government Medical College and Hospital, Cuddalore District – Fee structure- Revised – Orders – Issued.

#### ORDER:

In the Government Order first read above, orders have been issued by the Higher Education Department directing that the Rajah Muthiah Medical College attached to Annamalai University be handed over to Health and Family Welfare Department for treating it as Government Medical College, Cuddalore District. Apart from handing over the Rajah Muthiah Medical College and Hospital, Rani Meyyammai College of Nursing and Rajah Muthiah Dental College and Hospital shall also be handed over to Health and Family Welfare Department.

2. Consequent to the above orders of handing over of the said Institution to this Department, the Rajah Muthiah Medical College and Hospital, Chidambaram shall be treated as regular "Government Medical College and Hospital, Cuddalore District" with immediate effect. Among others, paragraph 3 of the Government order first read above has outlined the process to be followed and paragraph 3 (v) has mentioned the need for issue of separate orders on specific issues.

3. In continuation of the above, in respect of paragraph 3 (v) (b) of the Government order first read above, the Director of Medical Education has sent the proposal in letter second read above stating that already seats are being filled as per the norms of a State Government Colleges by surrendering 15% of seats to All India Quota and balance 85% seats under the State Quota by following all formalities including rules of reservations followed presently by treating it as a Self financing Medical College. In view of the Government orders issued treating it as a Government institution, the Director of Medical Education has proposed the adoption of Government fee structure and other charges from the date of issue of the order first read above.

4. After careful examination of the proposal of the Director of Medical Education, the Government hereby accord administrative sanction on the following:-

- a) The fees structure for the Medical (Under Graduate / Post Graduate) / Dental / Nursing courses of the institutions namely Rajah Muthiah Medical College and Hospital, Rani Meyyammai College of Nursing and Rajah Muthiah Dental College and Hospital, Chidambaram now taken over as Government institutions shall be as that of prevailing fees structure for the existing Government Medical / Dental / Nursing colleges as detailed below:-

- b) The fees structure above will be given prospective effect from the date of taking over of the said Colleges as Government institutions/colleges as per the Government Order referred above. The earlier existing fees prior to taking over, already paid by the students will not be refunded or adjusted against future payments. The benefit of Government fee structure as fixed from time to time will be extended to currently studying and forthcoming students.

5. The Director of Medical Education is also directed to take immediate steps to take over the properties and liabilities of the said colleges "as it is where it is" basis and send a detailed proposal for the same and also to take follow up action on Paragraph 3(v)(a) and para 3(v)(b) of the Government order first read above.

6. The Director of Medical Education is further directed to take affiliation process for bringing the said institutions under the Tamil Nadu Dr. MGR Medical University, Chennai immediately.
