The Mission Director, State Health Society has therefore requested the Government to issue orders for the release of a sum of Rs.26,16,66,667/- (Rupees Twenty six crore sixteen lakh sixty six thousand six hundred and sixty seven only) being the State and Central Share of Grants-in-Aid to the State Health Society for Health System Strengthening under National Rural Health Mission for the year 2017- 2018 as mentioned above and to authorize him to draw the above amount under National Health Mission through Treasury mode and credit it into State Health Society Account.

The Government after careful consideration has decided to accept the above proposal of the Mission Director, State Health Society and accordingly sanction a sum of Rs.26,16,66,667/- (Rupees Twenty six crore sixteen lakh sixty six thousand six hundred and sixty seven only) being the State and Central Share of Grants-in-Aid to the State Health Society for Health System Strengthening under National Rural Health Mission for the year 2017 – 2018.
