ORDER:

In the Government Order first read above, an amount of Rs.36,91,06,000/has been sanctioned towards the cost of vaccines supply under Routine Immunization and Pulse Polio (under Reproductive Child Health (RCH)) Anti TB Drugs (under Revised National Tuberculosis Control Programme (RNTCP)) for the year 2016-17 and to *book of expenditure in the books of accounts of Accountant General under the New Head of Account "2211 00 103 UB 09 Grants-in-aid 03 Grants for specific Schemes (General)", 2211 00 793 UB 09 Grants-in-aid 03 Grants for specific Schemes (SCSP)" and "2211 00 794 UB 09 Grants-in-aid 03 Grants for specific Schemes (STSP)".

- 2. In the Government Order second read above a sum of Rs.24,60,70,667/has been sanctioned towards the State Share contribution of Cost Adjustment (Kind Grant) of supplies of Routine Immunization Vaccines & Anti TB Drugs for 2016-17 under National Health Mission.
- 3. The Mission Director, National Health Mission has now stated that the Kind Grant already released by the Government of India towards the Routine Immunization, Pulse Polio Immunization and anti-TB drugs for the years 2014-15, 2015-16, 2017-18 and 2018-19 has not yet been booked as expenditure in the Books of Accounts of Accountant General, Tamil Nadu for want of budget allocation and hence the matching State Share could not be drawn till now. He has given the

details of Government of India share of KIND GRANT pending to be booked and the matching state share to be claimed are shown below:

The Mission Director, National Health Mission has therefore requested that necessary budget allocation for a sum of Rs.457,92,74,425/- (Rupees Four hundred and fifty seven crores ninety two lakes seventy four thousand four hundred and twenty five only) may be made to enable this office to Book the Accountant General's figure as booked in their Books of Account and to claim the matching state share.
- 6. The Government after careful examination have decided to accept the proposal of the Mission Director, National Health Mission and accordingly, sanction is accorded for a sum of Rs.457,92,74,425/- (Rupees Four hundred and fifty seven crore ninety two lakh seventy four thousand four hundred and twenty five only) and
