On careful consideration of the proposal, the Government of Tamil Nadu have decided to issue "Essentiality Certificate" to the applicant for starting of MD (Biochemistry) with an annual intake of 3 seats per year at Government Mohan Kumaramangalam Medical College, Salem from the academic year 2016-2017, subject to the condition that the approval of Medical Council of India / Government of India should be obtained before the students are admitted.

It is certified that:-

- (a) It is desirable to start MD (Biochemistry) with an annual intake of 3 seats per year in the public interest.
- (b) Starting of MD (Biochemistry) with an annual intake of 3 seats per year at Government Mohan Kumaramangalam Medical College, Salem is feasible.
- (c) The institution in the said department is having adequate clinical material as per the Medical Council of India norms.
