- 2. The corresponding 40% of the State share against the 60% of the Government of India share of Rs. 61,00,000/- (Rupees Sixty one lakh only) works out of Rs.40,66,666/- (Rupees Forty lakh sixty six thousand six hundred and sixty six only).
- 3. The Mission Director, National Health mission has therefore requested the Government to issue orders for the release of a sum of Rs.1,01,66,666/-(Rupees One crore one lakh sixty six thousand six hundred sixty six only) Share contribution of Grants-in-Aid to the Reproductive Child Health, Health System Strengthening and Non-Communicable Diseases Programme year 2018 2019 as mentioned above and to authorize him to draw the above amount under National Health Mission through Treasury mode and credit it into National Health mission Account.
- 4. The Mission Director, National Health Mission has also requested the Government to re-appropriate a sum of Rs.1,01,66,666 from the Head of Account 2211 00 103 UA 09 03 (General) to Head of Account 2211 00 794 UA 09 03 (STSP).
- 5. The Government after careful consideration has decided to accept the above proposal of the Mission Director, National Health Mission and accordingly:
 - i. Sanction is accorded to release a sum of Rs.1,01,66,666/- (Rupees One crore one lakh sixty six thousand six hundred and sixty six only) being the State and Central Share contribution of Grants-in-Aid for National Diseases Control Programme (NDCPs) for the year 2018 2019 to the Mission Director, National Health Mission and the same is re-appropriated from 2211 00 103 UA 09 03(General) to 2211 00 794 UA 09 03 (STSP).
