ORDER:

In Government Order read above, administrative sanction is accorded for establishing an Emergency Operations Centre (EOC) at State level in the Office of the Director of Public Health and Preventive Medicine at a total cost of Rs.209.70 lakh, with a budgetary provision of funds Rs.41.94 lakh, for the year 2017-18, at 20% of the total requirement to tackle the public health emergencies and to facilitate team work for taking decisions effectively without any delay in State level in coordination with State Disaster Management Authority, in case of adverse situations.

2. The Mission Director, National Health Mission has stated that in respect of the balance of funds required for above said civil works, necessary proposal has been included in PIP⁵ 2018-19 and the same has been approved by the Government of India with a budget provision of Rs.41.94 lakh. The balance of funds required has to be proposed in subsequent PIPs.

3. As per the directions issued in the Government orders Vide G.O(Ms) No.116, Health and Family Welfare (EAPII-2) Department, dated 25.3.2011, the fund Rs.41.94 lakh, approved for the above said works in the year 2018 - 19 has been remitted into Government of Tamil Nadu account vide Challan No.235 dated 02.7.2018 of SBI Treasury Branch, Chennai.

4. The funds now remitted are to be sanctioned for executing the civil works through Public Works Department.

5. The Mission Director, National Health Mission has requested necessary orders in this regard.

6. The Government carefully examined the issue and order as follows:-

- i. Sanction is accorded for the Fund of Rs. 41.94 Lakh approved for the year 2018 - 19 for constructing Emergency Operations Centre in the Office of the Director of Public Health and Preventive Medicine for executing the works through Public Works Department.

- ii. The Engineer in Chief and The Chief Engineer Buildings, Public Works Department, Chepauk, Chennai is permitted to issue orders to the Executive Engineers of the concerned division for the drawal of the fund.
- iii. The Mission Director is permitted to remit the balance of funds required for the works, as and when it is approved by the Government of India.
- iv. The Mission Director, State Health Society is directed to include the balance amount of Rs.125.82 lakh in the subsequent programme implementation plans without fail to utilize the same as per standard procedure.
- v. The Mission Director is permitted to remit the balance of funds required for the works as and when it is approved by Government of India in to Government account in the following Head of Account "0210 - Medical - 02 - Rural Health Services - 800-other Receipts - AD-Receipts from Government of India for National Rural Health Mission" (DPC-0210-02-800-AD-0008).
- vi. The expenditure sanctioned in para 6(i) above shall be debited to the following Head of Account. "4211 - 00 capital outlay on Family Welfare - 103 - Maternity and Child Health - Central Sector Schemes - SA National Component - Reproductive and Child Health Project - 16 Major works". (DPC No.4211 - 00 - 103 - SA - 1608)
- vii. The drawal of the fund be allowed pending provision in RE/FMA 2018 - 19, as the fund has been already remitted into Government account.
