ORDER:

The Managing Trustee, Ramakrishnan Education and Charities Trust, Trichy District has requested the Government to grant permission for starting of 5 Allied Health Science Courses in the name and style as "Krishna College of Paramedical and Allied Health Science", Trichy from the academic year 2020-2021.

- 2. In Government letter second read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed paramedical institution has fulfilled the conditions prescribed by the Government in the Government Order first read above.
- 3. In his letter third read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government and recommended to grant permission to the Managing Trustee, Ramakrishnan Education and Charities Trust, Trichy District to start 5 Allied Health Science Courses in the name and style as "Krishna College of Paramedical and Allied Health Science", Trichy from the academic year 2020-2021.

- 4. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education. The Government hereby grant permission to the Managing Trustee, Ramakrishnan Education and Charities Trust, Trichy District to start four years Allied Health Science Courses in the name and style as "Krishna College of Paramedical and Allied Health Science", in S.F. Nos. 41/4E, 42/1, 42/2A, 42/2B, 42/3, 42/8A, 42/8B, 42/11, 223/2, 223/6, 223/3, 224/2, 223/4, 222/16, 222/1A, 224/1B, 224/1C at Kottaimedu, Irungalur, Manachanallur Taluk, Trichy 621 105 from the academic year 2020-2021, subject to fulfill the following specific conditions along with other general conditions laid down in G.D (Ms) No.435, Health and Family Welfare (PME) Department, dated: 30.09.2019 as applicable to this proposal before admitting the students:-
 - The Trust should obtain conversion of building plan approval from Nursing College to Krishna College of Paramedical and Allied Health Science.
 - 2. The Trust should obtain recognition from the Rehabilitation Council of India, New Delhi for B.Sc., Audio &Speech Language Pathology course.
 - 3. The Trust should submit the renewal Certificate from the Tamil Nadu Pollution Control Board, Tiruchirapalli from 01.10,2020.
 - 4. The Trust should obtain affiliation from the Tamil Nadu Dr. M.G.R. Medical University, Chennal before admitting the students from the following courses:-
