ORDER:

The Hon'ble Minister for Health and Family Welfare Department has announced on 14.6.2018 on the Floor of Assembly that Specialist doctors, Nurses and other health workers will be appointed in the Reproductive and Child Health (RCH) Centre of Excellence established in Government medical college Hospitals at Thanjavur and Pudukottai and District Head Quarters Hospitals at Cuddalore and Tiruppur.

2. In Government Order first read above, orders have been issued for strengthening of Maternal and Child Health (MCH) wings in Government Ranee's Hospital. In Government Order second read above, orders have been issued for strengthening of Maternal and Child Health wings in Cuddalore and Tiruppur Government Hospitals. In Government Order 3rd read above, orders have been issued, among others, for strengthening of CEmONC centres in Thanjavur Medical College Hospital. These Maternal and Child Health wings which are Reproductive and Child Health Centre of Excellence have been established to provide quality health care services. These centres are proposed to provide state of art Reproductive and Child Health Care Services, Professional Education and training in the field of Reproductive and Child Health, Mentoring of Reproductive and Child Health services to Primary Health Centres and other Government Hospitals in that region.

- 3. The civil works in Pudukottal and Cuddalore CEmONC wing has been completed, nearing completion in Tiruppur and work in progress in Thanjavur CEmONC Centre.
- 4. As the bed strength has increased and as the bed occupancy rate is higher during the times of epidemic, the placement of additional Obstetricians and Gynecologists, Anesthetists and Pediatricians in the cadre of Assistant Professor, Staff Nurses and Multipurpose Hospital Worker in the above said 4 institutions are necessary to give Quality Care to the patients without interruption.

5. The proposed Human Resources was placed in PIP 2018-19 and has been approved in Record of Proceedings by the Government of India as follows:-

The posts of specialists are sanctioned in the cadre of Assistant Professor as per Government of Tamil Nadu norms. The contract salary of the Regular time scale pay posts of specialists and Staff Nurse will be remitted into State Treasury as per National Health Mission norms.

6. The above proposal has been approved by the Executive Committee in the 35th Executive Committee Meeting.

- 7. The Mission Director, National Health Mission has requested necessary orders in this regard.
- 8. The Government after careful examination have decided to accept the proposal of Mission Director, National Health Mission and issue the following orders:-
- i. Sanction is accorded for creation of 28 posts of Obstetricians and Gynaecologists, 12 posts of Anesthetists and 8 posts of Paediatricians in the Cadre of Assistant Professor in CEmONC Wings in Thanjavur and Pudukottai Government Medical College Hospitals and Cuddalore & Tiruppur Hospital as follows:-

- b. The Director of Medical and Rural Health Services will be the cadre controlling authority for the regular timescale Nurse posts.
- iii. The Mission Director, State Health Society is permitted to remit the salary component for the posts sanctioned in para 8 (i&ii) regular time scale posts into State Government account as and when its approved by Government of India under the following head of account:-
 - "0211-00 Family Welfare-800 other Receipts AN Receipts under National Rural Health Mission 21-03 Receipts from Central Government Health and Family Welfare (NRHM- Construction Sterilization Programme"). (DPC-0211-00-800-2136).
- iv. The cadre controlling authority in respect of regular posts of Medical Officers in Government Medical College Hospital is the Director of Medical Education

- and in respect of District Head Quarters Hospitals, Director of Medical and Rural Health Services, is the cadre controlling officer.
- v. The Mission Director, National Health Mission is permitted to place 24 posts of Multipurpose Hospital Worker, 6 each in CEmONC wings in Thanjavur, Pudukottai, Cuddalore and Tiruppur Hospitals on Outsourcing basis through respective District Health Society at National Health Mission norms (Rs. 6,500 per month).
- vi. The Mission Director, State Health Society is permitted to incur the expenditure for the above activity from National Health Mission approved funds.
- vii. The Mission Director, National Health Mission is requested to ensure that the contractual agreement between the Outsourcing Agency and State Health Society denies the opportunities of the employees to claim any right for absorption. The Outsourcing Agency shall also be held responsible for future litigation.

The Director of Medical and Rural Health Services and Director of Medical Education is directed to apply for sanction of advance from the Contingency Fund to Finance (BG-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. The Director of Medical and Rural Health Services and Director of Medical Education is also requested to send a draft explanatory notes for including the above expenditure in the Supplementary Estimate 2018-2019 to Fiance (BG-I/Health-1) Department without fail.
