ORDER:

The Managing Trustee, Dr. APJ. Abdulkalam Educational Charitable Trust, Illuppur, Pudukottai has requested the Government to grant permission to start four years B.Sc Allied Health Science Courses in Operation Theatre and Anaesthesia Technology and Physician Assistant in the name and style as "Mother Terasa Institute of Paramedical and Allied Health Sciences, Pudukottai" from the academic year 2019-2020.

- 2. In Government letter second read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust to consider their request.
- 3. The Director of Medical Education has constituted an inspection team to verify as to whether the proposed institution has fulfilled the conditions prescribed by the Government and the Tamil Nadu Dr. M.G.R. Medical University, Chennai and has submitted the proposal with the Inspection Report / Project Report along with his specific recommendation to the Government and requested to issue necessary orders.

- 4. In his letter third read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled all the norms prescribed by the Government as well as by the Tamil Nadu Dr. M.G.R. Medical University, Chennai and recommended to grant permission to the Managing Trustee, Dr. APJ. Abdulkalam Educational Charitable Trust, Illuppur, Pudukottai to start four years B.Sc Allied Health Science Courses in Operation Theatre and Anaesthesia Technology and Physician Assistant with an annual intake of each 20 students in the name and style as "Mother Terasa Institute of Paramedical and Allied Health Sciences, Pudukottai" from the academic year 2019-2020.
- 5. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education. Accordingly, the Government grant permission to the Managing Trustee, Dr. APJ. Abdulkalam Educational Charitable Trust, Illuppur, Pudukottai to start four years B.Sc Allied Health Science Courses in Operation Theatre and Anaesthesia Technology and Physician Assistant with an annual intake of each 20 (twenty) students in the name and style as "Mother Terasa Institute of Paramedical and Allied Health Sciences" in S.F. No.341/1A, 344/1A, Mettusalai, Veerappatty Panchayat, Illuppur Post & Taluk, Pudukkottai District from the academic year 2019-2020, subject to the following conditions:
 - a) Admission of students shall be made as per the rules fixed by the Government from time to time.
 - b) Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate undertaking stating that No CAPITATION FEE or any other fund in the name of building fund, etc. will be collected from the students who seek admission in the said nursing college.
 - c) The Trust should obtain affiliation from the Tamil Nadu Dr.M.G.R Medical University, Chennai before admitting the students.
 - d) The Government have the right to utilize the Government Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non compliance of rules and regulations of the Government by the Trust like, winding of course without valid reasons etc.

- e) The Institute so permitted to conduct the course will be allowed to shift / change the study centres only after completion of three years from the date of actual commencement of the course by the first batch of students, after getting orders of Government on inspection of the centres.
- f) The Trust should obtain the building plan approval from the Directorate of Town and Country and Planning (DTCP) for the proposed paramedical institution and submit to the Government before admitting the students.
- 6. The Director of Medical Education is directed to take necessary further action accordingly.
