**ORDER:**

The Hon'ble Minister for Health and Family Welfare Department has announced on 14.6.2018 on the Floor of Assembly that Tamil Nadu Accident and Emergency Care Initiative (TAEI) will be Strengthened by strengthening of District hospitals by sanctioning 141 Staff nurses in 18 District Hospitals.

2. The Mission Director, National Health Mission in his letter read above may stated that Road Traffic Accidents in Tamil Nadu has been increasing exponentially and the Government of Tamil Nadu has been meticulously taking several steps to reduce the fatality due to Road Traffic Accidents under the Tamil Nadu Accident and Emergency Care Initiative (TAEI). The post crash interventions include effective pre-hospital, in hospital and rehabilitation interventions such that the near death patients are revived and resuscitated in the golden hour. The Mission Director, National Health Mission is designated ex-officio commissioner of Trauma Care as per G.O.(Ms.)No. 231, Health and Family Welfare Department, dated 22.06.2017. One of the building blocks of TAEI is to ensure adequate Human resources in the TAEI centers such that good quality emergency care services are given to the public. The role of nurses has been acknowledged pivotal in this regard as they are the first ones to respond to the patients in the Emergency Room. The total number of TAEI centers identified in the State is 70, comprising of 25 Medical College Hospitals, 29 District Headquarters Hospital and 16 Sub District Hospitals.

3. The Mission Director, National Health Mission has further stated that TAEI intends to uniformly designate nurses working in Emergency Room as Triage nurse, Trauma Nurse Co-coordinators, and TAEI nurses who will be posted in Emergency Room (24 x 7) such that they are able to sort out and treat the patients at the right time eventually improving the quality of the service provided, thus reducing the fatality rate due to trauma and non-trauma emergencies. Now, it is proposed to create 141 Nurses in 18 TAEI District Headquarters Hospitals, as indicated below, in the ratio of 1:2 for regular and contract Nurses as per G.O (Ms) No.400, Health and Family Welfare Department, dated:16.12.2014. Thus 47 posts of Nursed will be in the time scale of pay in Level 14, Rs.36000 - Rs.114000 and these regular posts will be placed under the control of Director of Medical and Rural Health Services and the posts will be filled up from the present contract nurses who were selected through the Medical Services Recruitment Board (MRB) as per seniority. Remaining 94 will

be placed on contract basis with the salary of Rs.14000/ and they will be selected through Medical Services Recruitment Board as indicated below:-

4. The Mission Director, National Health Mission has further stated that the above proposal has been included in PIP and approved in Records of Proceedings 2018-19 by the Government of India. The Executive Committee has approved the above proposal.

5. The Mission Director, National Health Mission has therefore requested necessary orders in this regard.

6. After careful examination, the Government have decided to accept the proposal of Mission Director, National Health Mission and accordingly issue the following orders:-

- i. Sanction is accorded to create 47 regular posts of Staff Nurses in the following places in the minimum pay of Rs.36000/- (Level 14, Rs.36000 – Rs.114000) out of total 141 posts, following the ratio of 1:2 between regular and contract posts of Nurses as envisaged in G.O(Ms)No.400, Health and Family Welfare Department, Dated:16.12.2014.

- ii. The Director of Medical and Rural Health Services is the cadre control authority of the above said 47 posts of Nurses and these posts is filled up from the existing contract Nurses on the basis of seniority maintained by the Director of Medical and Rural Health Services.
- iii. The Mission Director, National Health Mission is permitted to remit the contract salary of the 47 staff nurses on regular time scale of pay into Government Account in the following Receipt head of account and to release salary of the 94 staff nurses on contract to the respective District Health Society.

- iv. The Expenditure sanctioned in para 6(i) above shall be debited to the following Head of account:-  
 2210 MEDICAL AND PUBLIC HEALTH – 01 Urban Health Services – Allopathy – 110 Hospitals and Dispensaries – State's Expenditure – AA District Headquarters Hospitals – 01 salaries

vi. The above 94 posts of contract Nurses be recruited through Medical Recruitment Board with the salary of Rs. 14,000/- with annual increment of Rs.500/- only.

7. The expenditure sanctioned in para 6(i) above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director of Medical and Rural Health Service is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form A appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Director of Medical Education is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2018-19 to Finance (BG-I) Department at the appropriate time without fail.
