### **ORDER:**

In the letter read above, the Additional Director of Medical and Rural Health Services (TM) and State TB Officer has stated that as per the National Strategic Plan (NSP) 2017-2025, the Government of Tamil Nadu is implementing the four principles ie., Detect, Treat, Prevent and Build and accordingly strategic document for TB Free 2025 has been draft which clearly shows out the key strategies to achieve "TB Free Tamil Nadu 2025". The Government of India informed that the National TB HIV Coordination Committee and the National Technical Working Group for TB-HIV has been reconstituted as **National TB-comorbidity Coordination Committee and the National Technical Working Group for TB-comorbidities** and it has recommended during its first meeting to constitute the State TB-comorbidity Coordination Committee (STCC) State Technical Working Group on TB-comorbidities (STWG) and District TB-comorbidity Coordination Committee (DTCC) by replacing the TB HIV collaborative Frame Work.

2. The Additional Director of Medical and Rural Health Services (TM) and State TB Officer has requested that necessary orders may be issued for the constitution of the State TB comorbidity Coordination Committee (STCC), State Technical Working Group (STWG) on the TB comorbidities and the District TB-comorbidity Coordination Committee (DTCC).

3. The Government after careful consideration have decided to accept the proposal of the Additional Director of Medical and Rural Health Services (TM) and State TB Officer and accordingly issue orders for the constitution of the committees as detailed below:-
