## ORDER:

The Mission Director, State Health Society in his letter read above has stated that the Government of India have released funds to Tamil Nadu State Government for implementation of strengthening of Immunization Programme for the year 2014-15. Government of India have requested to ensure 25% State contribution based on the release of funds by Government of India.

- 2. The Mission Director, State Health Society has further stated that the corresponding 25% of the State share against the 75% of the Government of India release of Rs.4,32,17,000/- (Rupees Four crore thirty two lakh and seventeen thousand only) is works out to Rs.1,44,05,667/- (Rupees One crore forty four lakh and five thousand six hundred and sixty seven only). In order to implement the schemes approved under National Health Mission programmes during 2014-15 under strengthening of Immunization, he has requested to issue orders for the release of a sum of Rs.5,76,22,667/- (Rupees five crore seventy six lakh twenty two thousand six hundred and sixty seven only) towards Central and State contribution of grants in aid to the State Health Society and to authorize the Mission Director, State Health Society/ Project Director, Reproductive and Child Health Project, Tamil Nadu, to draw a sum of Rs.5,76,22,667/- (Rupees five crore seventy six lakh twenty two thousand six hundred and sixty seven only) under National Health Mission through Treasuries.
- 3. The Government, after careful consideration, has decided to accept the proposal of the Mission Director, State Health Society and they accordingly sanction a sum of Rs. 5,76,22,667/- (Rupees five crore seventy six lakh twenty two thousand six

hundred and sixty seven only) for implementation Strengthening of Immunization Programme during 2014-2015.
