### ORDER:

In the Government Order first read above, orders have been issued directing the Tamil Nadu Medical Services Corporation to release Rs.17.00 lakhs in favour of Director, Institute of Mental Health for procuring the equipments required for the modernization of Bakery unit attached to the Institute of Mental Health and with a direction that the initial cost of Rs.17 lakh released by Tamil Nadu Medical Service Corporation should be reimbursed from the net profit earned in due course.

2. Subsequently, in Government Order second read above, the Director, Institute of Mental Health was also remitted to repair the existing infrastructure, electricity, etc., for an amount of Rs.3.00 lakhs from the annual maintenance budget of the Institution.

3. The Managing Director, Tamil Nadu Medical Services Corporation has stated that based on the above, tenders were finalized and orders were placed for procurement of equipments at a total cost of Rs. 19,52,998.68/- .

4. Based on the approval of the Board of Tamil Nadu Medical Services Corporation the additional amount of Rs.2,52,999/- was met from its Administrative and maintenance fund and supplied the equipment to the Institution. The Managing Director, Tamil Nadu Medical Services Corporation has stated that so far an amount of Rs.7,48,508/- only has been reimbursed by the Institute of Mental Health upto 30.11.2017. Meanwhile, in the Annual Meeting of State Mental Health Authority

held on 26.09.2017, it has been decided to request the Managing Director, Tamil Nadu Medical Services Corporation to waive the balance amount to be paid to the Tamil Nadu Medical Services Corporation towards procuring bread making machine for the benefit of improved mentally ill patients.

5. The Director of Medical Education in letter dated: 01.12.2017 has requested the Managing Director, Tamil Nadu Medical Service Corporation, to waive the balance of the machinery cost involved in the procurement of bread making machinery cost, since the machinery has been supplied to the Institute of Mental Health for the welfare of the patients as well as part of rehabilitation Programme.

6. Based on the above, the subject was placed before the Board of Tamil Nadu Medical Services Corporation in its 144<sup>th</sup> meeting held on 21.12.2017 for waiving the balance amount of Rs.12,04,491/- to be reimbursed by the Institute of Mental Health, Chennai and the Board has approved the same, subject to approval of the Government.

7. The Government after careful examination of the request of Managing Director, Tamil Nadu Medical Services Corporation decided to accept and accordingly ordered for waive the balance amount of Rs.12,04,491/- (Rupees Twelve lakh four thousand nine hundred and ninety one only ) as on 30.11.2017 to be reimbursed to the Tamil Nadu Medical Service Corporation by the Institute of Mental Health, Chennai, which was incurred towards purchase of equipment for modernization of bakery unit.
