ORDER:

In the Government Order read above, orders were issued to establish Geriatric units in 31 Districts excluding Chennai District under National Health Mission and human resource was sanctioned to Geriatric units in five Government Medical College Hospitals at Madurai, Coimbatore, Tirunelveli, Salem and Trichy Districts.

2. In the letter read above, the Mission Director, State Health Mission has stated that for establishing a Geriatric unit in Government Medical College Hospital, the following Human Resources are necessary:-

3. The Mission Director, State Health Society has also stated that the proposal for Human resources for the Geriatric units in three Government Medical College Hospitals at Thanjavur, Villupuram and Vellore Districts has been included in the PIP and approved by the Government of India in Record of Proceedings 2017-2018 and supplementary Record of Proceedings 2017-2018 except Staff Nurse post in as follows:-

3. The above proposal has been placed before the 34th Executive Committee meeting vide agenda No.7 and the same was approved.

4. The Mission Director, State Health Society has therefore requested Government order in this regard.

5. After careful examination, the Government have decided to accept the proposal of Mission Director, State Health Society and according the issue the following orders:-

- i. Sanction is accorded to create the following posts in time scale of pay under the administrative control of Director of Medical Education in three Government Medical College Hospitals at Thanjavur, Villupuram and Vellore Districts (one post each to the three Geriatric units to the above college).

- iii. Sanction is accorded to place the services of the following posts in Outsourcing as per National Health Mission norms in three Government Medical College Hospitals at Thanjavur, Villupuram and Vellore Districts.

7. The expenditure towards the staff cost of posts sanctioned in para 5 (i) above is an item of "New Instrument of Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature the expenditure may be initially met by drawl of an advance from the Contingency Fund. The Director of Medical Education is directed to apply for sanction of advance from the Contingency Fund to Finance (BG-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. The Director of Medical Education is also requested to send a draft explanatory notes for including the above expenditure in the Supplementary Estimate 2018-2019 to Finance (BG-I / Health – 1) Department without fail.
