**ORDER:**

The Managing Trustee, Annai JKK Sampoorani Ammal Charitable Trust, Namakkal District has requested the Government to grant permission to start a 4 years Bachelor in Pharmacy Course in the name and style as “JKK Munirajah Institute of Health Sciences College of Pharmacy” at Erode District with an annual intake of 60 students from the academic year 2014-2015.

2. The Director of Medical Education has constituted an inspection team to verify as to whether the proposed College of Pharmacy has fulfilled the conditions prescribed by the Government and the Pharmacy Council of India, New Delhi. The Director of Medical Education has submitted the proposal with the Inspection report / Project Report along with her specific remarks to the Government and requested Government to issue necessary orders.

3. The Government have examined the case in detail in the light of the Inspection Report and the remarks of the Director of Medical Education and grant permission to the Managing Trustee, Annai JKK Sampoorani Ammal Charitable Trust, Namakkal District to start 4 years Bachelor in Pharmacy Course in the name and style as “JKK Munirajah Institute of Health Sciences College of Pharmacy” at Thookkanaickanpalayam (PO), Gobichettipalayam (TK), Erode District with an annual intake of 60 students from the academic year 2015-2016, subject to the following conditions:-

- a) The building completion certificate for the College and Hostel of the proposed JKK Munirajah Institute of Health Sciences College of Pharmacy should be obtained from the Directorate of Town and Country Planning (DTCP) and produced before the students are admitted to B.Pharm course.

- b) Admission of students shall be made as per the rules fixed by the Government from time to time.
  - c) Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate undertaking stating that NO CAPITATION FEE or any other fund in the name of building fund, etc. will be collected from the students seeking admission in the Private Self Financing Pharmacy Colleges.
  - d) The Trust should obtain recognition / suitability / affiliation from the Pharmacy Council of India and Tamil Nadu Dr. M.G.R. Medical University respectively before admitting the students.
  - e) The Government have the right to utilize the Government Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non compliance of rules and regulations of the Government by the Trust like winding up of course without valid reasons, etc.
  - f) The Institute so permitted to conduct the course will be allowed to shift / change the study centres only after completion of three years from the date of actual commencement of the course by the first batch of students, after getting orders of Government on re-inspection of the centres.
  - g) The approval for the building plan for the College and Hostel from the Directorate of Town and Country Planning (DTCP) should be obtained and produced before the students are admitted as per the undertaking of the Trust.
5. The Director of Medical Education is directed to take necessary further action accordingly.
