ORDER:

The Director of Medical Education has forwarded a proposal for construction of building for Hepatology Department to strengthen the Hepotology and Liver Transplant Unit in Rajiv Gandhi Government General Hospital, Chennai.

- 2. The Director of Medical Education has forwarded the rough cost estimate prepared by the Engineer in Chief and Chief Engineer (Buildings), Public Works Department, Chennai Region for construction of building for Hepatology Department in Rajiv Gandhi Government General Hospital, Chennai for an amount of Rs.22.50 crore for the year 2014-2015 and Rs.24.75 crore for the year 2015-2016.
- 3. The Director of Medical Education has requested the Government to accord administrative and financial sanction for a sum of Rs.22.50 crore for the year 2014-2015 and Rs.24.75 crore for the year 2015-2016 assuming an escalation of 10%, for construction of building for Hepatology Department in Rajiv Gandhi Government General Hospital, Chennai.
- 4. The Government have examined the proposal of the Director of Medical Education in detail and accord administrative and financial sanction for to a sum of Rs.16,69,48,000/- (Rupees Sixteen Crore Sixty Nine Lakh and Forty Eight Thousand only) for the Hepatology Department in Rajiv Gandhi Government General Hospital, Chennai to carry out the works given in the table below subject to the conditions enumerated below:-

Conditions of sanction:-

- i) the equipment and amenities should be met only under Infrastructure Development Fund (IDF)/consumable component of Chief Minister Comprehensive Health Insurance Scheme (CMCHIS) fund.
- ii) no additional posts would be created. If there is any additional need, the same should be met by redeployment.
- iii) no provision should be made for centralized A/C
- 5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-.
 - "4210-Capital Outlay on Medical and Public Health 01-Urban Health Services 110 Hospital and Dispensaries (including Pharmacy) Schemes in the Twelfth Five Year Plan- II State Plan JA Buildings 16 Major Works" (D.P.C 4210-01-110-JA-1602)".
- 6. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Buildings) is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the contingency Fund to Finance (BG.I) Department directly in Form A appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Chief Engineer (Buildings) is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2015-2016 to Finance Department at the appropriate time without fail.
