ORDER:

In the reference first read above, the Director of Medical Education has stated that the Government of India has approved Rs.5.00 crore for 5 Medical institutions i.e. Regional Institute of Ophthalmology and Government Ophthalmic Hospital, Chennai and 4 Government Medical Colleges in Dharmapuri, Salem, Thiruvannamalai and Kanyakumari Districts for upgrading the equipments in the respective Medical Colleges for the year 2016-2017 under the National programme for Control of Blindness.

- 2. In the reference second read above, the Mission Director, State Health Society has stated that since funds have been credited under Human resource in Medical Education and the head of account should be in Director of Medical Education instead of Reproductive Child Health (RCH) head of account.
- 3. The Director of Medical Education has stated that the Government of India has sanctioned a sum of Rs.5.00 crore as grant-in-aid for the financial year 2016-2017 under National Programme for control of Blindness (NPCB). In order to implement the schemes under the above said programme, the Project Director, Tamil Nadu State Blindness Control Society may be authorized to draw the sanctioned amount of Rs. 5.00 crore which has been credited into the State Government account and requested to issue necessary orders in this regard.
- 4. The Government after careful examination have decided to accept and sanction a sum of Rs.5.00 crore (Rupees five crore only) (Central Share) for procurement of Ophthalmic equipments in the five Medical Institutions, namely Regional Institutions of Ophthalmology, Government Medical Colleges, Dharmapuri,

Salem, Tiruvanamalai & Kanyakumari under the National Programme for Control of blindness.

- 5. The expenditure sanctioned in para 4 shall be debited under the following head of account:- [Demand No. 1903]
 - 2210 Medical and Public Health
 - 01 Urban Health
 - 110 Hospitals and Dispensaries Centrally Sector Schemes SX. Establishment of State Ophthalmic Cell
 - 19 Machinery and Equipments
 - 01 Purchase (DPC 2210 01 110 SX 1914)
- 6. Necessary funds will be provided in the RE / FMA 2017- 2018, Pending provision of such funds, the Director of Medical Education is authorized to draw and disburse the amount mentioned in para 4 above. However, this expenditure shall be brought to the notice of the legislature by Specific inclusion in the Supplementary Estimates 2018-2019. The Director of Medical Education is also requested to include this expenditure while sending the budget proposals for RE/FMA 2018-2019 and draft explanatory notes for Supplementary Estimates 2018-2019 to Government in Finance (Health –II/BG-I) Department without fail.
