ORDER:

The Mission Director, State Health Society in his letter read above has stated that the Central funds under the Centrally sponsored Schemes related to National Health Mission are routed through the Treasuries as part of the State plan and requested to provide for Central Share of National Health Mission in the State Budget. The Government of India have transferred and credited a sum of Rs.55,24,53,000/- into State Government account as their 75% share of Grants in Aid for the financial year 2014-15 for implementation of Infrastructure Maintenance under Family Welfare Programme. Government of India have requested to ensure the 25% of State contribution based on the release of funds by Government of India.

2. The Mission Director, State Health Society has further stated that the corresponding 25% of the State share against the 75% of the Government of India release of Rs.55,24,53,000/- (Rupees Fifty five crore twenty four lakh and fifty three thousand only) works out to Rs.18,41,51,000/- (Rupees Eighteen crore forty one lakh and fifty one thousand only). Since Government of India have transferred the grants to State Government for drawal of amount through Treasury route from 2014-15, the amount of State share will have to be drawn from State Budget. The Mission Director, State Health Society / Project Director , Reproductive and Child Health Project, Tamil Nadu has therefore, requested to issue Government orders for the release of a sum of Rs.18,41,51,000/- (Rupees Eighteen crore forty one lakh and fifty one thousand only) towards release of State contribution of grants in aid to the State Health Society and to

authorize him to draw a sum of Rs.18,41,51,000/- (Rupees Eighteen crore forty one lakh and fifty one thousand only) under National Health Mission through Treasury mode.

3. The Government, after careful consideration, has decided to accept the proposal of the Mission Director, State Health Society and they accordingly sanction a sum of Rs.18,41,51,000/- (Rupees Eighteen crore, forty one lakh and fifty one thousand only) being the 25% of State Share as matching grant to the State Health Society, Tamil Nadu for implementation of Infrastructure maintenance under Family Welfare Programme.

4. The above expenditure sanctioned in para 3 above shall be debited to the following heads of account:
