Medical Education – Migration of second year MBBS Students from one Government Medical College to another Government Medical College – Permitted – Orders – Issued.

In the Government Order first read above the Government issued prescribing certain regulations based on the regulation of the Medical Council of India, New Delhi for Migration of 1st Year MBBS students on completion of their 1st year MBBS examination, from one Government Medical College to another Government Medical College on compassionate grounds, such as:-

- a) Death of parent / supporting guardian of the student during the first year MBBS., study of the student (or)
- b) Illness of the applicant causing disability which he / she is currently studying (or)
- c) Disturbed conditions declared by Government in the concerned geographic area etc.,
- 2. As the Medical Council of India, New Delhi framed the above three conditions over a long back, no one falls/fulfills on the said conditions and so the second year vacant seats in the Government Medical Colleges kept idle without considering any request made by the individuals for migration for so many years. Considering the above position, in its Migration Rules and Regulations, the Medical Council of India has amended its regulations as follows:-

6 (1) Migration of students from one Medical College to another Medical College may be granted on any genuine ground subject to the availability of vacancy in the college where migration is sought and fulfilling the other requirements laid down in the Regulations. Migration will be restricted to 5% of the sanctioned intake of the college during the year. No migration will be permitted on any ground from one medical college to another located within the same city.

On the above lines, if any genuine request comes from the second year students, it has to be taken into consideration for transfer. Candidates from Private Medical Colleges are not eligible for consideration for the migration from Private Medical Colleges to Government Medical Colleges on the above said grounds due to various administrative reasons.

3. The following students made representations to Government to consider their request to migrate to the Government Medical Colleges in the existing vacancy. The request of the individuals are as follows:-

Among them, one Thiru. R.Neeraj Kumar, has filed a Writ Petition (W.P.No. 28140 of 2017) before the High Court of Madras with a prayer to direct the Government to migrate him to any one of the Government Medical Colleges in Chennai. In its order, dated 4.09.2018, the Hon'ble High Court of Madras, among others, has passed the orders follows;

".... Since the petitioner is entitled to apply for transfer after completion of the I year course, respondents 1 to 3 are directed to take a decision with regard to the transfer of the petitioner within two weeks from the date of receipt of a copy of this order as two vacant seats are available, one in Madras Medical College and the other in Stanley Medical College. The decision taken shall be produced before this Court". 4. In view of the above, the Director of Medical Education has been requested to convene the Expert Committee meeting to scrutinize certain individuals' representations applied for migration and furnish the recommendations of the Committee, to the Government, early. Accordingly, the Director of Medical Education has convened the Expert Committee meeting on 03.10.2018 to scrutinize the request relating to migration of the second year MBBS students from one Government Medical College to another Government Medical College, with the following officials:-
