### ORDER:

The Project Director, Tamil Nadu Health System Reform Program has sent proposal for recurring cost of Trauma Registry established in 27 Trauma Care Centres which was approved in the 3<sup>rd</sup> meeting of State Empowered Committee held on 27.08.2021.

2. The Project Director, Tamil Nadu Health System Reform Program has stated that it is essential to have concrete data on the pre-hospital, hospital management and disposition of all trauma cases for analysis and improvement of trauma care services. During the year 2019-2020, as a part of First year activity, the trauma registry was developed and established in 2 centers (Govt. Vellore Medical College, Vellore and Govt. Hospital, Ambur) on a pilot basis using Open Data Kit (ODK) format. During the year 2020-2021, as a part of second year activity, the trauma registry was established in 26 trauma care centres. (26+1=27 including Government Vellore Medical College)

3. The Tamil Nadu Health System Reform Program has furnished the recurring cost of 27 Trauma Care Centres which was established as per G.O. (Ms) No.519, Health and Family Welfare (EAPI/1) Department, dated 03.12.2020 as follows:-

4. The Project Director, Tamil Nadu Health System Reform Program has requested the Government to issue necessary orders in this regard.

5. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program have decided to accept the same and issue following orders:-

- i) Sanction is accorded for an amount of Rs.90,72,000/- (Rupees Ninety Lakh and Seventy Two Thousand only) to the Director of Medical Education towards salary for 54 Trauma Registry Assistants in 27 Trauma care centres as detailed in annexure annexed to this G.O and the Director of Medical Education is authorized to draw and disburse the amount sanctioned.
- ii) Sanction is accorded for an amount of Rs.15,78,000/- (Rupees Fifteen Lakh and Seventy Eight Thousand only) to the Project Director, Tamil Nadu Health System Reform Program towards establishment of IT platform and Operational Cost of Trauma Registry Software and the Project Director, Tamil Nadu Health System Reform Program is authorized to draw and disburse the amount sanctioned.
- iii) A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorates and facilities involved which should be operated by joint signatory.

6. The expenditure sanctioned in para 5 (i) above, shall be debited under the following head of account:-

2210 - Medical and Public Health – 01 Urban Health Services – Allopathy – 110 Hospitals and Dispensaries - Externally Aided Project – PE - Tamil Nadu Health Systems Reforms Project – Administrated by Director of Medical Education – 309 Grants in Aids 03 – Grants for specific schemes
