

National Health Mission – 50 Primary Health Centres upgraded in 2008 – 2009 - Additional posts to 15 remaining Upgraded Primary Health Centres under National Rura! Health Mission - Sanctioned - Orders – Issued.

ORDER:

In Government Order first read above, 50 Primary Health Centres have been upgraded under National Rural Health Mission into 30 bedded institutions. The infrastructure including buildings, equipments and staff required for the Upgraded Primary Health Centres are provided under National Rural Health Mission.

- 2. In Government Order second read above, the additional Posts for the 35 Upgraded Primary Health Centres (out of 50 Upgraded Primary Health Centres sanctioned under NRHM) have been created.
- 3. The Mission Director, State Health Society has informed that the Director of Public Health and Preventive Medicine has requested for additional posts to the 15 remaining Upgraded Primary Health Centres, as the posts are essential for the normal functioning of the Upgraded Primary Health Centres and for effective delivery of specialized health service to the rural public.
- 4. The Mission Director, State Health Society has further stated that as per National Rural Health Mission Guidelines, all posts should be on contract basis. However, during the National Programme Coordination Committee (NPCC) meeting, the State has informed the Government of India that the posts of Medical Officers and other Para Medical Staff/Clerical Staff will be filled up on regular time scale of pay as per the State Government Policy and pay and allowances to the incumbents will be drawn through the treasury. The consolidated amount / contractual pay to staff budgeted under National Rural Health Mission, will be remitted into the treasury, for the staff in position, based on the details of staff position received from the District Health Society. This procedure is being followed in respect of 75 Upgraded Primary Health Centres and 35 Upgraded Primary Health Centres upgraded earlier under National Rural Health Mission.
- 5. In Government Order third read above, among other things, a unified category of Hospital Worker, Sanitary worker and Nursing Assistant Grade II, named as Multipurpose Hospital Worker had been created. The above post shall be filled up through Employment Exchange on contract basis. The contract appointment shall be initially for a period of one year, which can be extended up to five years and

the payment for unskilled worker shall be made as per the rates fixed by the concerned District Collectorates. The details of 115 posts proposed to 15 Upgraded Primary Health Centres, are given below:

6. Out of 50 Primary Health Centres upgraded with 30 beds in Government Order first read above, additional posts have already been sanctioned to the 35 upgraded Primary Health Centres in Government Order second read above. The Mission Director, State Health Society has now sent proposals for the sanction of additional posts to the 15 upgraded Primary Health Centres. The Mission Director, State Health Society has informed that the Staff cost for the 15 Upgraded Primary Health Centres was included in PIP 2014-15 and subsequent PIPs every year. The proposals are being approved by Government of India for every year including 2017-18. It may be also stated that out of 115 posts, 10 posts of Staff Nurses are on contract basis, 28 posts of Multi purpose Hospital Worker are on out sourcing. 8 posts of Driver post shall be filled up after vehicle sanctioned by the State Government since National Health Mission does not provide funds for purchase of vehicles. Thus remaining 69 posts are on regular time scale and it is required as follows:-

- ii. The Mission Director is permitted to place 10 posts of Staff Nurse on contract basis through Medical Services Recruitment Board and pay their salary as per rules in force.
- iii. The Mission Director, State Health Society is permitted to place the services of the 28 Multipurpose Hospital Worker posts through outsourcing on contract basis as per National Health Mission norms on Daily wages at the rate fixed by concerned District collector (Approximately Rs.235/- per day for 27 days).
- iv. The post of Medical Officers, Multipurpose Hospital Worker and Lab Technicians are allotted to the 15 Upgraded Primary Health Centres as follows:-

v. The Mission Director National Health Mission is permitted to reimburse the staff cost in respect of the posts mentioned in para 8 (i) above to the following State Government head of account:-

vi. The expenditure sanctioned in para 8(i) above shall be debited to the following Head of Account:-

"2210 MEDICAL AND PUBLIC HEALTH – 03 Rural Health Service – Allopathy – 103 Primary Health Centres State's Expenditure – AH National Rural Health Mission Scheme – 01 Salaries".

- vii. The Mission Director, National Health Mission is requested to ensure that the contractual agreement between the Outsourcing Agency and State Health Society denies the opportunities of the employees to claim any right for absorption. The Outsourcing Agency must be held responsible for any future litigation.
- 9. The expenditure sanctioned in para 8 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director of Public Health and Preventive Medicine is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form A appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Director of Medical Education is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2018 19 to Finance (BG.I) Department at the appropriate time without fail.
