ORDER:-

The Director of Medical and Rural Health Services in her letter read above has stated that among others that the State Planning Commission has called for innovative proposal under the Tamil Nadu Innovation Initiative Schemes (TANII) for the year 2019-20. Accordingly, she has submitted the proposal to the State Planning Commission for the establishment of three Oxygen generating plants in two Government Taluk Hospitals at Valparai and Kodaikanal and Government Headquarters Hospital at Uthagamandalam. The State Planning Commission has recommended for the establishment of the Oxygen generating plants at Government Taluk Hospital at Valparai and Kodaikokanal and at Government Headquarters Hospital, Uthagamandalam, at a total cost of Rs.225.00 lakh.

2. The Director of Medical and Rural Health Services has therefore requested the Government.

- i. To permit her to establish Oxygen generation plant in two Government Taluk Hospital at Valparai, Kodaikanal, and Government Headquarters Hospital, Uthagamandalam, under the Tamil Nadu Innovation Initiative Schemes (TANII) for the year 2019-2020.
- ii. She has also required to permit her to purchase the above said equipments required for implementation of the programme through the Tamil Nadu Medical Services Corporation Limited, Chennai.

3. The Government have examined the proposal of the Director of Medical and Rural Health Services based on the recommendation of the State Planning Commission. The Government accordingly, do and hereby direct that the Director of Medical and Rural Health Services is permitted to establish the

Oxygen generator plant in Government Taluk Hospitals at Valparai and Kodaikanal, and Government Headquarters Hospitals at Uthagamandalam under Tamilnadu Innovation Initiative Schemes (TANII) funds at a total cost of Rs.225.00 lakh (Rupees Two crore twenty five lakh only) (unit cost - Rs.75.00 lakh) as detailed in the annexure. The Director of Medical and Rural Health Services is also permitted to procure the equipment mentioned in the annexure, which are required for establishing the Oxygen generation plant through the Tamil Nadu Medical Services Corporation Limited, Chennai.

4. The amount sanctioned in para 3 above shall be debited to the following head of Account:

"2210-Medical and Public Health-01 Urban Health Services – Allopathy-110 Hospital and dispensaries – State's Expenditure – MI Establishment of Oxygen Generation Plant in Secondary Care Hospitals – Scheme under State Innovation Fund – 347 Stores and Equipment – 01 Stores"

Pending provision of such funds, the Director of Medical and Rural Health Services is authorized to draw and disburse the amount sanctioned in para 3 above. However, this expenditure shall be brought to the notice of the legislature by Specific inclusion in the supplementary Estimates 2020-2021. The Director of Medical and Rural Health Services is also requested to include this expenditure while sending the budget proposals for Revised Estimates / Final Modified Appropriation 2020-2021 and also send necessary draft explanatory notes for Supplementary Estimates 2020-2021 to Government in Finance(BG-I/Health-II) Department at an appropriate time without fail.
