ORDER :

In the circumstances reported by the Additional Director of Medical Education / Secretary, Selection Committee in the letter read above, the Government after careful consideration, sanction a sum of Rs.1,33,21,628/- (Rupees one crore thirty three lakhs twenty one thousand six hundred and twenty eight only) to meet the expenditure in connection with the work relating to the selection and admission of candidates for the Post Graduate Degree / Diploma / 6 years M.Ch. - ii) The actual expenditure incurred along with the statement of expenditure should be submitted to Government within 15 days of completion of the Post Graduate Selection process.

2. The Director of Medical Education is also directed to submit the actual expenditure incurred along with a copy of the audited certificate of the Accountant General of Tamil Nadu to the Government.




