### ORDER:

In his letter read above, the Director of Medical and Rural Health Services has requested the Government to approve the regular panel for the post of Nursing Superintendent Grade-I by approving the estimate of vacancy for the said post for the year 2014-2015.

2. The Government have examined the proposal of the Director of Medical and Rural Health Services carefully and found that the individuals considered for the post of Nursing Superintendent Grade-I have not completed their probation in the feeder post of Nursing Superintendent Grade-II, due to the fact that they were promoted to the post of Nursing Superintendent Grade-II on temporary basis and the post comes under the purview of Departmental Promotion Committee of Tamil Nadu Public Service Commission and the approval of Departmental Promotion Committee is yet to be obtained. Hence, the Government have decided to promote the candidates temporarily under rule 39(a)(i) of the Tamil Nadu State and Subordinate Services by relaxing the General Rule 36(a) of the Tamil Nadu State and Subordinate Services, since, they have not completed their probation in the feeder category of Nursing Superintendent Grade-II. The Government accordingly, do and hereby direct that the following 46 Nursing Superintendent Grade-II be promoted temporarily as Nursing Superintendent Grade-I under General Rule 39(a)(i) of the Tamil Nadu State and Subordinate Services by relaxing the General Rule 36(a) of the Tamil Nadu State and Subordinate Services Rules in favour of them without conferring any rights in the post of Nursing Superintendent Grade-I, till their names are included in the regular panel.

4. The Director of Medical and Rural Health Services is directed to issue necessary posting orders to the above individuals.

5. The Director of Medical and Rural Health Services is also directed to take necessary action to regulate the services of the candidates in the cadre of Nursing

Superintendent Grade-II by placing the proposal before the Departmental Promotion Committee.

6. It is certified that the individuals mentioned at para-2 above are fully qualified to hold the post of Nursing Superintendent Grade-I.
