ORDER:

The Director of Medical Education in his letters read above has stated that it is proposed to have a new building for 120 bedded Ophthalmology Department in the Thanjavur Medical College Hospital Campus instead of existing old building with 115 bedded Ophthalmology Department functioning in the campus of Government Raja Mirasdar Hospital, Thanjavur. He has, therefore, sent the proposal for construction of building and purchase of equipment for establishment of Regional Eye Care Centre in Thanjavur Medical College Hospital, Thanjavur, with the detailed justification for the establishment of Regional Eye Care Centre in Thanjavur Medical College Hospital.

2. After careful examination of the proposal of the Director of Medical Education, the Government accord administrative and financial sanction for a sum of Rs.16.47 crore and release a sum of Rs.4.47 crore (Rupees Four crore and forty seven lakh only) for the year 2019-2020 for construction of New Eye Block at a cost of Rs. 16.47 crore to Government Raja Mirasudhar Hospital, Thanjavur. Balance amount will be released based on the requirement of funds.

3. The Director of Medical Education is directed to request the Mission Director, National Health Mission to include the proposal under National Health Mission in the ensuing Project Implementation Programme (PIP) for 2019-2020/ 2020-2021, get it sanctioned and remit the amount into the State Government Account.

4. The expenditure sanctioned in para 2 above, shall be debited to the following Head of Account:-

“4210 – Capital Out lay on Medical and Public Health – 01 – Urban Health Services – 110 – Hospitals and Dispensaries (including Pharmacy) – State’s Expenditure – JA Buildings – 416 – Major Works – 01 Major Works”. (IFHRMS - DPC: 4210-01-110-JA-41601)
(Old - DPC: 4210-01-110-JA-1602)

5. The expenditure sanctioned in para 2 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. The Director of Medical Education is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2019-2020 to Finance (BG-I) Department at the appropriate time without fail. The expenditure shall be incurred only after inclusion of this sanction in the Supplementary Estimates and passing of the Supplementary Appropriation Act.

6. This order issues with the concurrence of the Finance Department, vide its U.O.No.59266 /Health-II/2019, dated 29.11.2019. ASL No. 2330 (Two thousand three hundred and thirty)
