ORDER:

The Chairman, Selvam Educational and Charitable Trust, Vadakangulam, Tirunelveli District has requested the Government to grant permission for starting of three courses in Allied Health Science in the name and style as “Rajas Institute of Allied Health Sciences”, Vadakangulam, Tirunelveli District from the academic year 2020-2021.

2. In Government letter second read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed paramedical institution has fulfilled the conditions prescribed by the Government in the Government Order first read above.

3. In his letter third read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government and recommended to grant permission to the Chairman, Selvam Educational and Charitable Trust, Vadakangulam, Tirunelveli District to start three courses in Allied Health Science in the name and style as "Rajas Institute of Allied Health Sciences", Vadakangulam, Tirunelveli District from the academic year 2020-2021.

4. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education. The Government hereby grant permission to the Chairman, Selvam Educational and Charitable Trust, Vadakangulam, Tirunelveli District to start four years duration of Allied Health Science Courses in the name and style as "Rajas Institute of Allied Health Sciences", in Survey. No.65/2, Raja Nagar, Vadakangulam, Tirunelveli – 627 116 from the academic year 2020-2021, subject to fulfillment of the following specific conditions along with other general conditions laid down in G.O (Ms) No.435, Health and Family Welfare (PME.2) Department, dated: 30.09.2019 as applicable to this proposal before admitting the students:-

- i. The Trust should obtain building plan approval from the Directorate of Town and Country and Planning (DTCP) for the proposed paramedical institution.
- ii. The Trust should obtain building completion certificate from the competent authority. i.e. PWD Engineer.
- iii. The Trust should obtain Clearance Certificate from the Tamil Nadu Pollution Control Board, Tirunelveli.
- iv. The Trust should obtain affiliation from the Tamil Nadu Dr. M.G.R. Medical University, Chennai before admitting the students for the following courses:-
