



ABSTRACT

State Health Society - Tamil Nadu - National Urban Health Mission - Establishment of Nine Urban Primary Health Centers under Madurai Corporation - Creation of New posts - Administrative and Financial sanctioned - Orders - Issued.

ORDER:

In the Government Order first read above, administrative sanction was accorded for the establishment of 280 Urban Primary Health Centers including 243 existing facilities under the control of Urban Local Body and Director of Public Health and Preventive Medicine and 37 New Urban Primary Health Centers.

2. In the reference second read above, the Mission Director, State Health Society has stated that in the above 243 existing facilities 31 Urban Primary Health Centers in Madurai were included. But in Madurai, out of total 31 Urban Primary Health Centers, the following 9 Urban Primary Health Centers do not have sanctioned the posts of Medical Officer, Pharmacist and Support staff:

Since urban health services should not get affected, the Director of Public Health and Preventive Medicine took immediate steps through diversion or deputation of necessary Human Resources thus providing un-interrupted services in these health facilities. Hence, as per the revised gap analysis, 9 posts of Medical Officers, 9 Pharmacists and 18 Multipurpose Hospital Worker (For each Urban Primary Health Centers x2 as per National Urban Health Mission norms) are required for these 9 new Urban Primary Health Centers in Madurai Corporation.

3. The Mission Director, State Health Society has stated that the above proposal has been included in the PIP and got approval in Record of Proceedings 2018 - 2019 by the Government of India as follows:

4. The above proposal has also been approved by the Executive Committee in the 35th Executive committee meeting and requested necessary orders in this regard.

5. The Government after careful consideration have decided to accept the proposal of The Mission Director, National Health Mission and issue orders as follows:-

- i. Sanction is accorded to create one post each to the nine Urban Primary Health Centers mentioned at para 1 above and the Director of Public Health and Preventive Medicine will be the Cadre Controlling authority for these posts:-

- ii. The Director of Public Health and Preventive Medicine is permitted to recruit 9 pharmacists through Medical Recruitment Board on contractual basis.

1.	Pharmacist Rs.12,000/- per month(Contractual pay)	9	Must have passed +2 in a recognized school with science subject. A Diploma in Pharmacy. Must have registered with Tamil Nadu Pharmacy Council and must keep the Registration alive by renewing it regularly every year. (OR) The candidates who possess a degree (i.e. Bachelor of Pharmacy, apart from the above mentioned minimum General Educational (1&2) Qualifications.

- iii. The Mission Director, National Health Mission is permitted to place the services of 18 posts of Multipurpose Hospital Worker through the city Health Officer of Madurai corporation as per rules inforce as follows:-

- iv. The special rules / adhoc rules governing the posts under administrative control of Director of Public Health and Preventive Medicine is also applicable to the posts sanctioned for Urban Primary Health Centers under National Urban Health Mission.
- v. For Medical Officer appointed in regular time scale of pay under National Urban Health Mission in Corporation, salary shall be drawn through the treasury by the concerned City Health Officer under whose control the Urban Primary Health Centers are attached.
- vi. For paramedical staff, (Pharmacist and Multi Purpose Hospital Worker) consolidated monthly salary as approved by Government of India will be paid from National Health Mission fund. The salary will be paid through the city health officers for Urban Primary Health Centers in Madurai Corporation.
- vii. The Director of Public Health and Preventive Medicine and National Health Mission is requested to ensure that the contractual agreement between the Outsourcing Agency and State Health Society denies the opportunities of the employees to claim any right for absorption. The Outsourcing Agency held responsible for future litigation.
- viii. The amount sanctioned in para 5(i) shall be debited under the following Head of Account
"2210 Medical and Public Health – 01 Urban Health Services – Allopathy 200 other Health Schemes – AL Urban Primary Health Centres under National Urban Health Mission" – 01 Salaries'.
(DPC 2210 01 200 AL 01 03).
- ix. The Mission Director, National Health Mission is permitted to remit the Salary Component of the posts created in para 5(i) above in the following Receipt Head of account

6. The expenditure sanctioned in para 5(viii) above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director of Public Health and Preventive Medicine is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form A appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Director of Public Health and Preventive Medicine is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2018 – 19 to Finance (BG.I) Department at the appropriate time without fail.
