ORDER:-

During the Budget Speech of 2014 - 2015, among others, the Government of India have announced that the National Centre of Ageing would be established in Chennai and conveyed administrative approval for a sum of Rs.126.87 crore

(Non-Recurring Rs.97.75 crore and Recurring Cost – Rs.29.12 crore) for setting up of National Centre of Ageing at Chennai are as detailed below :-

- 2. In the Government Order second read above, the Government of Tamil Nadu have accorded administrative sanction for a sum of Rs.78.00 crore for construction of building for National Centre of Ageing in the premises of King Institute of Preventive Medicine and Research, Guindy, Chennai under the aegis of Madras Medical College, Chennai.
- 3. The Government of India have released a sum of Rs.78.00 crore for civil works and the corresponding orders issued by the Government are as detailed below:-

4. In the Government Order eighth read above, the Government of Tamil Nadu have accorded Revised Administrative and Financial Sanction for a sum of

Rs.87.99 crore with an additional expenditure of Rs.9.99 crore against the original sanction of Rs.78.00 crore.

- 5. The Director of Medical Education in the letter tenth read above has stated that the Government of India have released for a sum of Rs.19.75 crore credited to the State Government Account as non-recurring grant for machinery and equipment and ambulance for setting up of National Centre of Ageing in the premises of King Institute of Preventive Medicine and Research Centre, Guindy, Chennai under the aegis of Madras Medical College, Chennai under National Programme for Health Care of the Elderly during the financial year 2018–2019.
- 6. The Director of Medical Education has, therefore, requested the Government to accord sanction for the equipment required for the National Centre of Ageing under the aegis of Madras Medical College, Chennai and to release the funds for a sum of Rs.19.50 crore released by the Government of India credited into the State Government Account to Tamil Nadu Medical Services Corporation Limited, Chennai to initiate the process of procurement of machinery and equipment and successfully implement.
- 7. The Government after careful examination of the proposal of the Director of Medical Education in detail and decided to accept the same. Accordingly, the Government direct that Administrative and Financial Sanction be accorded for a sum of Rs.19.50 crore (Rupees Nineteen crore and Fifty lakh only) as Non-Recurring Grant towards procurement of machinery and equipment for the Establishment of National Centre of Ageing in the premises of King Institute of Preventive Medicine and Research, Guindy, Chennai under the aegis of Madras Medical College, Chennai under National programme for Health Care of the Elderly.
- 8. The expenditure sanctioned in para 7 above shall be debited under the following Head of Account [Demand No.19-03]

- 10. The Director of Medical Education is Estimating, Reconciling and Controlling Authority for the new head of account at para 8 above.
- 11. The pay and Accounts Officer / Treasury Officers concerned are directed to open a new head of account.
- 12. The expenditure sanctioned in para-7 above shall constitute an item of "New Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director of Medical Education is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form A appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Director of Medical Education is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2019-2020 to Finance (BG-I) Department at the appropriate time without fail.
