### ORDER:

In Government Order second read above, administrative sanction has been accorded to Mission Director, National Health Mission to execute civil work at a total cost of Rs.1200 lakhs for construction of Out Patient Blocks to 20 Primary Health Centres. In respect of the balance fund required for the above said works, a sum of Rs. 240 lakhs at 20% of the total cost of Rs.1200 lakhs had been approved in Record of Proceedings 2018-19 and has been remitted into Government account.

2. The Mission Director, National Health Mission has therefore requested necessary Government orders in this regard.

3. The Government after careful consideration have decided to accept the proposal of the Mission Director, State Health Society and accordingly issue following orders:-

- i. Sanction is accorded for a sum of Rs.2,40,00,000/- (Rupees Two crore forty lakhs only) for execution of Civil Works through Public Works Department.
- ii. The Engineer in Chief Engineer (Buildings) Public Works Department, Chepauk, Chennai is permitted to issue orders to the Executive Engineers of the concerned divisions for the drawal of funds.
- iii. The Mission Director is permitted to remit the balance funds required for the work as and when it is approved by Government of India.

4. The amount sanctioned in para 3(i) above shall be debited to the following Head of Account:-

"4211 00 Capital Outlay on Family Welfare – 103 Maternity Child Health State's Expenditure – AA Civil Works under National Health Mission Scheme – 16 Major Works".
