ORDER:

In the Government Order reference first cited, administrative sanction has been accorded for the construction of additional building for 9 existing ANM Schools at a total cost of Rs.625 lakh and sanction also accorded for a sum of Rs.312 lakh for construction of additional building for 9 existing ANM Schools through Public Works Department. Only Rs.312 lakh has been sanctioned in the above Government Order though the remittance has been made for 312.48 lakh.

2. In respect of the balance of funds Rs. 312.52 lakhs required for the above said civil works, necessary proposals have been included in PIP 2018-19. The proposals are approved in the Record of Proceedings 2018-19.

3. A sum of Rs.312.52 lakhs (Rupees three crore twelve lakh and fifty two thousand only) being the fund approved for the year 2018-19 for the civil works as detailed below has been remitted to Government of Tamilnadu, vide challan No.224 dated: 06.07.2018 of SBI. Treasury Branch, Chennai.

4. The funds now remitted are to be sanctioned for executing the civil works through Public Works Department.

5. The Mission Director, National Health Mission has requested necessary orders in this regard.

6. The Government after careful consideration have decided to accept the above proposal of the Mission Director, National Health Mission and accordingly issue the following orders:

- a. Sanction is accorded for a sum of Rs,3,13,00,000/- (Rupees Three crore thirteen lakhs only). The fund of Rs.3,12,52,000 now remitted the fund of Rs.48,000 already remitted but not included in previous sanction for executing the civil works through Public Works Department.
- b. The Engineer and Chief Engineer Buildings, Public Works Department, Chepauk, Chennai is permitted to issue orders to the Executive Engineers of the concerned divisions for the drawal of funds.

7. The expenditure sanctioned in para 6(a) above shall be debited to the following Head of account.
