The Director of Medical and Rural Health Services in the letter read above, has stated that a Detailed-Project Report along with proposal for establishing new Medical College Hospital in Cuddalore District has been submitted to the Government of India for approval.

2. The District Collector, Cuddalore has allotted 58.49 acres of land in Survey No. 117/2 in Arisiperiyankuppam Village of Cuddalore district for the proposed Government Medical College and Hospital under the administrative control of Director of Medical and Rural Health Services

3. The Director of Medical and Rural Health Services has also stated that the Director of Medical Education, Chennai has requested the Directorate of Medical and Rural Health Services to transfer of 23.67 Hectare of land (i.e) 58.46 acre of land in survey No. 117/2 under the administrative control of the Director of Medical and Rural Health Services to the Director of Medical Education side for establishing New Medical College and Hospital in Cuddalore District.

The Director of Medical and Rural Health Services has stated that she has no objection to transfer 35.00 acres of land in survey No. 117/2 in Arisiperiyankuppam Village of Cuddalore District which is now under administrative control of her Directorate to the Director of Medical Education for establishing New Government

Medical College and Hospital in Cuddalore district. She has requested Government orders in this regard.

The Government have examined the proposal of the Director of Medical and Rural Health Services and grant permission to transfer the 35.00 acres of vacant land in survey No. 117/2 in Arisiperiyankuppam Village of Cuddalore District under the administrative control of the Director of Medical and Rural Health Services to the Director of Medical Education control for establishment of New Medical College and Hospital in Cuddalore District.
