ORDER:

In the Government Order first read above an administrative sanction has been accorded for the construction of 23 warehouses in the following Health Unit Districts at the rate of Rs.30 lakh each, totally Rs.690 lakh (100%) and an amount of Rs.345/-lakh has been sanctioned for construction of warehouses.

3. The balance of funds Rs. 345 lakhs at 50% of the total cost of Rs. 690 lakhs required has been approved by Government of India in Record of Proceedings 2018-19 and the amount has been remitted into Government of Tamil Nadu account vide Challan No.384, dated 13.6.2018 of SBI Treasury Branch, Chennai. The remitted funds Rs.345 lakh have to be sanctioned for executing the works through Public Works Department .

4. The Mission Director, National Health Mission has therefore requested necessary orders in this regard.

5. The Government after careful examination have decided to accept the proposal of the Mission Director, National Health Mission and accordingly issue the following orders:

- I. Sanction is accorded for an amount of Rs.3,45,00,000/- lakhs (Rupees three crore forty five lakhs only) for construction of warehouse through Public Works Department.
- II. The Engineer in Chief and Chief Engineer buildings Public Works Department , Chepauk, Chennai is permitted to issue orders to the Executive Engineers of the concerned divisions for the drawal of funds.

6. The above expenditure sanctioned in para 5 (i) above shall be debited to the following Head of Account.

"4211 – 00 Capital Outlay on Family Welfare – 103 Maternity and Child Health State's Expenditure – AA civil works under National Health Mission scheme – 16 Major Works".
