ORDER:

In the Government order first read above, among other things, orders were issued, transferring the following Dispensaries / Hospitals from the Director of Medical Education to the Director of Medical and Rural Health Services with effect from 1st October, 2011:-

2. Now, the Director of Medical Education has stated that petitions are received from the public that the services provided in the Peripheral Hospital, Periyar Nagar is inadequate. Hence, she has requested the Government to issue necessary orders to transfer the administrative control of the Government Peripheral Hospital, Periyar Nagar, Chennai to the control of the Director of Medical Education, Chennai from the Director of Medical and Rural Health Services, Chennai to provide necessary better treatment to the patients.

3. The Director of Medical and Rural Health Services has endorsed the views of the Director of Medical Education in respect of Peripheral Hospital, Periyar Nagar, Chennai and has further stated that there is dearth of manpower in that Directorate. Hence, the Director of Medical and Rural Health Services has requested that the following dispensaries may also be transferred back to the Directorate of Medical Education, in order to avoid criticism among public, press, media, etc.,

4. The Government have examined the proposal of the Director of Medical Education in the light of the remarks of the Director of Medical and Rural Health Services in detail and decided to accept it. Accordingly, the Government pass the following orders:-

- a) The administrative control of the following Dispensaries/Hospitals be transferred from the Director of Medical and Rural Health Services to the Director of Medical Education, subject to the following conditions with effect from 01.03.2015.

b) Conditions:-

- i. The Director of Medical Education shall be the budget estimate and controlling officer of the above hospitals / dispensaries from the financial year 2014-2015. Funds allotted to the institution in the B.E., shall be utilized by the respective institution. For additional funds, the Director of Medical Education shall send proposals in the R.E. 2014-2015.
- ii. The transfer of these Hospitals / Dispensaries to the control of the Director of Medical Education comprises of all components including infrastructure, machines and equipment, various category of Medical, Non-Medical, Para-Medical, Ministerial, Basic Service posts along with personnel, vehicles, etc., The Medical Officers including staff, Buildings, Equipment, Machines, Vehicles, etc., shall be deemed to have been transferred to the control of the Director of Medical Education from 1.3.2015. The Director of Medical Education should not transfer any staff of transferred hospitals to the Director of Medical and Rural Health Services (DM&RHS) side against their wish. If any Medical Officer and other personnel want to move to the Director of Medical and Rural Health Services side, he/she should give it in writing to the DM&RHS and the DM&RHS should consider their request on priority and merit.
- iii. In respect of Medical Officers in these Hospitals/ Dispensaries, without Post Graduate qualification and teaching experience their willingness for transfer to the Director of Medical Education side may be obtained and if they are not willing for transfer to Director of Medical Education side, they may be retained in the DM&RHS side and equal number of Medical Officers may be transferred from DM&RHS side to the Director of Medical Education side.

- iv. Disciplinary action if any against the personal working in these Hospitals / Dispensaries, including Medical Officers which have arisen during the period from the date of transfer of the institution to Director of Medical and Rural Health Services as per G.O.(Ms) No.193, Health and Family Welfare Department, dated: 01.08.2011, till the date of reverting back to Director of Medical Education side may be processed and finalized by the Director of Medical and Rural Health Services.
- v. Similarly all the Court cases including compensation cases awaiting for final orders which have arisen during the period from the date of transfer of these to Director of Medical and Rural Health Services as per G.O.(Ms)No.193, Health and Family Welfare Department, dated:01.08.2011, till the date of reverting back to Director of Medical Education side, may be processed and finalized by the Director of Medical and Rural Health Services.
- vi. All the files relating to creation of posts construction of additional buildings, purchase of equipment, etc., now dealt at Director of Medical and Rural Health Services side shall be transferred to the Director of Medical Education side with proper acknowledgement.
- vii. The unutilized amount from the amount remitted to Tamil Nadu Medical Services Corporation for the Peripheral hospital by the Director of Medical and Rural Health Services for the year 2013-2014 be debited to the account of the Director of Medical Education.

5. The Director of Medical Education/Director of Medical and Rural Health Services are instructed to take necessary follow up action in this regard.
