ORDER:

In the Government Order first read above, among others administrative sanction has been accorded to Mission Director, National Health Mission for construction of Four Maternity Blocks, civil works for upgradation of twelve Primary Health Centres, upgradation of Infrastructure in Comprehensive Emergency Obstetric and Newborn care (CEmONC) Centres / First Referral Units (FRUs) at a total cost of Rs.2054.50 lakh and ratification has also been given for depositing the amount of Rs.902.50 crore released by Government of India out of the total funds for the following civil works.

2. The total amount for upgradation of twelve primary Health Centres is Rs.1440/-lakh (Rs.120 *12). Out of this amount, Rs.288/- lakh has been sanctioned in the Government Order first read above. In respect of the balance of funds Rs.1152 lakhs (Rs.120 lakh x 80% x 12 Upgradation of Primary Health Centres) required for the construction of the new buildings to 12 Upgradation of Primary Health Centres, a detailed proposal has been included in PIP 2018-19 and also approved by Government of India in Record of Proceedings 2018 – 19.

 - 4. The Mission Director, National Health Mission has stated that the funds Rs.1152 lakh approved in Record of Proceedings 2018-19 towards the provision of balance of funds for civil works of 12 Upgradation of Primary Health Centres, has to be remitted into Government account thereafter a sum of Rs.150 lakh had been sanctioned from 'State Balanced Growth Fund' (SBGF) for constructing Upgradation of Primary Health Centre building to Primary Health Centre Karumanthurai, Salem District, by the State Planning Commission, Chennai, vide Proceedings No.203/ SBGF/ RD&DP/SPC /2017, dated 23.2.2017, along with other facilities such as Blood Storage Centre, Combined Quarters and Compound Wall and the funds were fully released.
 - 5. The funds Rs.24 lakh released from for the said Upgradation of Primary Health Centre Karumanthurai, Salem District is not utilized. Besides, the balance of funds Rs.96 lakh, approved now in Record of Proceedings 2018-19, at 80% of the total cost Rs.120 lakh for the buildings of above said Upgradation of Primary Health Centre need not be remitted now. Consequently, the balance funds Rs.1056 lakh required for 11 Upgradation of Primary Health Centres only as detailed below, at the rate of Rs.96 lakh each is remitted now.
