The Mission Director, National Health Mission in the letter read above has stated that the Government of India have transferred and credited into State Government Account its share towards release of Grants-in-Aid for 3rd Installment Infrastructure Maintenance during 2018 - 19 as detailed below:-

The corresponding 40% of the State share against the 60% of the Government of India share of Rs.40,93,36,000/- (Rupees Forty crore ninety three lakh and thirty six thousand only) works out of Rs.27,28,90,667/- (Rupees Twenty seven crore twenty eight lakh ninety thousand six hundred and sixty seven only).

2. The Mission Director, State Health Society has therefore requested the Government to issue orders for the release of a sum of Rs.27,28,90,667/- (Rupees Twenty seven crore twenty eight lakh ninety thousand six hundred and sixty seven only) being the State Share contribution of Grants-in-Aid to the 3rd Installment Infrastructure Maintenance under National Rural Health Mission for the year 2018 - 2019 as mentioned above and to authorize him to draw the above amount under National Health Mission through Treasury mode and credit it into National Health Mission Account.

3. The Government after careful consideration has decided to accept the above proposal of the Mission Director, National Health Mission and accordingly sanction a sum of Rs.27,28,90,667/- (Rupees Twenty seven crore twenty eight lakh ninety thousand six hundred and sixty seven only) being the State Share contribution of Grants-in-Aid to the 3rd Installment Infrastructure Maintenance under National Rural Health Mission for the year 2018 – 2019.

4. The amount sanctioned in para 3 above shall be debited to following heads of account:-
