ORDER:

In the Government order first read above, the Government have accorded Administrative and Financial Sanction for a sum of Rs.16,69,48,000/- for the construction of Hepatology Department in Rajiv Gandhi Government General Hospital, Chennai, to carry out the works given in the table mentioned below subject to the conditions enumerated below:-

Conditions for sanction:

- i. The equipment and amenities should be met only under Infrastructure Development Fund (IDF/Consumable component of Chief Minister comprehensive Health Insurance scheme (CMCHIS) fund.
- ii. no additional posts would be created. If there is any additional need, the same should be met by redeployment.
- iii. no provision should be made for centralized Air condition.

2. In the letter second read above, the Director of Medical Education has stated that the Engineer-in-Chief (Buildings) and Chief Engineer (Buildings), Chennai Region,

Public Works Department, Chennai has stated that the Dean, Madras Medical College, Chennai has requested to prepare an estimate work for providing additional amenities in the construction of building for Hepatology Department in Rajiv Gandhi Government General Hospital, Chennai. He had requested the Public Works Department authorities to prepare Rough cost estimate for the construction of building for Hepatology Department in Rajiv Gandhi Government General Hospital, Chennai. Accordingly, the Chief Engineer (Buildings), Chennai Region has prepared the Rough cost estimate based on the Public Works Department Plinth area rates 2017-2018 for the scheduled items and for non-schedule items lowest competitive rates based on the quotation obtained from the market. The detailed estimate for the following items works out to Rs.1,70,50,000/- for the year 2018-2019, duly countersigned by the Director of Medical Education.

1. Providing of Furniture items in rooms, wards & operation theatres.
2. Providing and fixing of bed head panel for medical gas outlet point in ICU.
3. Providing and fixing of LEAD door shutters.
4. Providing and fixing of cupboard shutters.
5. Providing and laying of Granite slab for countertop platforms.

3. The Director of Medical Education has, therefore, requested the Government to issue necessary administrative and financial sanction for a sum of Rs.1,70,50,000/- for the year 2018-2019 for providing additional amenities to the construction of building for Hepatology Department in Rajiv Gandhi Government General Hospital, Chennai.

4. The Government after careful examination of the proposal of Director of Medical Education in detail and accord necessary administrative and financial sanction for a sum of Rs.1,70,50,000/- (Rupees One Crore Seventy Lakhs and Fifty Thousand only) for providing additional amenities to the construction of building for Hepatology Department in Rajiv Gandhi Government General Hospital, Chennai.

5. The expenditure sanctioned in para 4 above shall be debited to the following Head of account:- [Demand No. 39.02]

“4210.Capital Outlay on Medical and Public Health – 01.Urban Health Services – 110. Hospitals and Dispensaries (Including Pharmacy) - State's Expenditure – JA. Buildings – 16. Major Works (DPC 4210-01-110-JA-1602)”.

6. The expenditure sanctioned in para 4 above shall constitute an item of “New Instrument of Service” and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Buildings), Public Works Department is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to the Finance (BG.I) Department directly, in Form-A appended to the Tamil Nadu Contingency Fund Rules, 1963, along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from the Finance (BG.I) Department. The Chief Engineer (Buildings), Public Works Department is requested to send necessary explanatory notes to include the above expenditure in the

Supplementary Estimates for the year 2018-2019 to the Finance (BG.I) Department at the appropriate time without fail.

7. This order issues with the concurrence of the Finance Department vide its U.O.No.60698/Health-II/2018, Dated 07.12.2018 and ASL No.2134 (Two thousand one hundred and thirty four).
