## **ORDER:**

In the letter read above, the Project Director, Tamil Nadu Health Systems Project has stated that exemption from deduction of corpus fund had already been given to TKR, THR and Hearing Aid. It was observed that the cost of the hearing aid had been considerably reduced under Chief Minister's Comprehensive Health Insurance Scheme. Hence supply of hearing aid under Chief Minister's Comprehensive Health Insurance Scheme may very well be managed within the package cost of Rs.8,000/- even if the exemption already given may be withdrawn.

- 2. The project Director, Tamil Nadu Health Systems Project has requested the Government to issue orders to withdraw the already given exemption for hearing aid.
- 3. The Government after careful examination has decided to accept the request of the Project Director, Tamil Nadu Health Systems Project and issue the following orders:
  - I. To ratify the action of the Project Director, Tamil Nadu Health Systems Project for having exempted from deduction of Corpus fund of Chief Minister's Comprehensive Health Insurance Scheme for hearing aid till date.
  - II. To withdraw the already given exemption for hearing aid by the Project Director, Tamil Nadu Health Systems Project with effect from this order.
