- 3. In the letter fourth read above, the Director of Medical Education has requested to issue orders for renewal of MoU of ESI- PGIMSR, K.K. Nagar with Madras Medical College, Chennai for a period of 6 months from the date of expiry i.e., 31.05.2013, and also stated that the said college has already availed, for a period of six months from the date of expiry the facilities of the basic Medical Science department.

The Government, after careful examination, have decided to accept the recommendation of the Director of Medical Education and ratify the action of the Dean, Madras Medical College, Chennai in having renewed the MoU with ESI- PGIMSR, K.K.
